NOTICE OF PREPARATION OF A REGULATORY IMPACT STATEMENT

Road Safety (Driving Instructors) Regulations 2010

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared for the proposed Road Safety (Driving Instructors) Regulations 2010.

The objectives of the proposed regulations are to:

- provide for the application for and issue of driving instructor authorities;
- set out conditions that must be followed by holders of driving instructor authorities;
- require driving instructors to produce their driving instructor authority and identity photograph if requested to do so by a member of the police force.

The proposed regulations remake the existing Road Safety (Driving Instructors) Regulations 1999, which sunset on 23 February 2010.

The RIS assesses the benefits and costs of the proposed regulations, concluding that the benefits outweigh the expected costs.
