ROAD SAFETY (VEHICLES) REGULATIONS 2009

Declaration of Container Vehicle Routes

1. Purpose

The purpose of this notice is to declare that certain routes are container vehicle routes for the purposes of the Road Safety (Vehicles) Regulations 2009 (in this notice referred to as the Vehicles Regulations).

2. Authorising provision

This notice is made under regulation 6(d) of the Vehicles Regulations. Regulation 6(d) provides that the Roads Corporation, by notice published in the Government Gazette, may declare a route to be a container vehicle route for the purposes of those Regulations.

3. Commencement

This notice comes into operation on the date it is published in the Government Gazette.

4. Revocation

The notice published in Government Gazette No. S 157 on Monday 22 August 2005 entitled Notice Declaring Container Vehicle Routes is revoked.

5. Expiry

This notice expires on 9 November 2014.

6. Declaration

For the purposes of regulation 6(d) of the Vehicles Regulations, I, George Mavroyeni, delegate of the Roads Corporation, declare the following routes to be container vehicle routes –

Footscray –

- Whitehall Street, between Napier Street and Hopkins Streets; and
- Hopkins Street between Whitehall Street and Dynon Road; and

Port Melbourne –

- Cook Street, between Todd Road and West Gate Freeway on ramp; and
- Dockside Road; and
- Lorimer Street, between Todd Road and Docklands Highway (Montague Street); and
- Todd Road, between Lorimer Street and Williamstown Road; and
- West Gate Freeway, between Docklands Highway (Montague Street) and the on ramp at Cook Street and the off ramp at Todd Road; and
- West Gate Freeway off ramp at Todd Road; and
- West Gate Freeway on ramp at Cook Street; and
- Williamstown Road, between Todd Road and the Yarra River; and

Appleton, Swanson and Victoria docks area –

- Anderson Road; and
- Appleton Dock Road; and
- Coode Road; and
- Dock Link Road; and
- Enterprize Road; and
- Mackenzie Road; and

SPECIAL

West Melbourne –

- Docklands Highway, between Whitehall Street and West Gate Freeway; and
- Dynon Road, between Hopkins Street and Link Road (Western Link), except the Moonee Ponds Creek Bridge; and
- Lloyd Street, between Radcliffe Street and the rail yards, except any overhead rail bridge; and
- Radcliffe Street; and
- Sims Street.

Note: Words and phrases in this notice have the same meanings as in the **Road Safety Act 1986** and the Regulations under that Act.
