VICTORIA PLANNING PROVISIONS
Notice of Approval of Amendment
Amendment VC74

The Minister for Planning has approved Amendment VC74 to the Victoria Planning Provisions (VPP) and all planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by amending:

- Clause 52.27 – Licensed Premises to:
 - remove the need for a permit to vary a liquor licence prescribed in Part 6, Regulation 31 of the **Liquor Control Reform Regulations 2009**.
 - make a minor grammatical correction to the introduction of the exemption provisions.
 - cross-reference the referral and notice provisions.
- Clause 66 – Referral and Notice Provisions to:
 - make the Director of Liquor Licensing a referral authority for an application under Clause 52.27 associated with a hotel, tavern or nightclub that will operate after 1 am.
 - provide notice to the Chief Commissioner of Victoria Police of an application under Clause 52.27 for a hotel, tavern or nightclub that will operate after 1 am.
 - clarify existing notice and referral exemptions with a minor administrative change.
