MAJOR SPORTING EVENT ORDER – 2010 AUSTRALIAN MASTERS

Order in Council

The Governor in Council under section 7 of the **Major Sporting Events Act 2009** makes a major sporting event order in relation to the 2010 Australian Masters, as follows:

The 2010 Australian Masters is specified as a major sporting event under section 7(1) of the **Major Sporting Events Act 2009** and as an aerial advertising event under section 8(2)(c) of that Act. The event venue for the event is specified in the table below along with other matters relating to the event.

| Part of the Act which applies: | Part 3 applies to the event. Part 4 applies to the event area. Part 8 applies to the event venue. |
