Marine Act 1988

SECTION 15 NOTICE

I, Diane Julie Bates, the Director Maritime Safety (as delegate of the Director, Transport Safety) on the recommendation of Colin McQuillen, Business Support Officer, Southern Rural Water (the Waterway Manager for Lake Glenmaggie), hereby give notice under section 15(1) of the **Marine Act 1988** that:

- (1) between 7.00 am Saturday 30 October 2010 and 5.00 pm Sunday 31 October 2010 bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved with the Glenmaggie and District Boat Club – Victorian Powerboat Championships, is prohibited on all the waters of Lake Glenmaggie north-west of an imaginary line between the waters edge at Coongulla Point and the waters edge at Cemetery Point;
- (2) between 7.00 am Saturday 30 October 2010 and 5.00 pm Sunday 31 October 2010 vessels involved in the Glenmaggie and District Boat Club – Victorian Powerboat Championships, are excluded from the requirements of Clause 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988**;
- (3) at the completion of the event or as announced by organisers of the Glenmaggie and District Boat Club – Victorian Powerboat Championships, the waters will revert to the provisions of Schedule 111 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
