Melbourne City Link Act 1995

NOTICE OF PARTIAL REVOCATION OF LINK ROAD – WESTERN LINK

I, Tim Pallas, Minister for Roads and Ports and Minister administering the **Melbourne City Link Act 1995** ('the Act'), in accordance with section 61A(3) of the Act, give notice that I have today made a revocation of part of the Link Road – Western Link declaration pursuant to section 61A(1) of the Act. A copy of that partial revocation is printed with this notice.

On the publication of this notice in the Government Gazette, by operation of section 61A(4) the road specified in the revocation ceases to be –

- (a) a freeway or an arterial road within the meaning of the **Road Management Act 2004**; and
- (b) a road open to and for use by the public for passage with vehicles, and all rights, easements and privileges existing or claimed in it as a road either in the public or by any body or person as incident to any express or implied grant or past dedication or supposed dedication or by user or operation of law, cease; and
- (c) a highway within the meaning of the **Road Safety Act 1986**.

The revocation applies to the road described in Schedule A and on the attached plan.


