GREATER GEELONG PLANNING SCHEME
Notice of Approval of Amendment
Amendment C232

The Minister for Planning has approved Amendment C232 to the Greater Geelong Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment facilitates the construction of the Geelong Ring Road – Section 4C and the reservation of land for the southern section of the Armstrong Creek Railway Station. The Amendment:

- applies a Public Acquisition Overlay (PAO3) to land required for the Geelong Ring Road Project and inserts an incorporated document titled ‘Geelong Ring Road – Section 4C Incorporated Document, June 2010’ into the Schedule to Clause 52.03 and the Schedule to Clause 81.01 to allow the land identified in the incorporated document to be used and developed for the purposes of the Geelong Ring Road – Section 4C;
- applies a Public Acquisition Overlay (PAO9) to the land required for the southern section of the Armstrong Creek Railway Station;
- deletes Schedule 8 to the Development Plan Overlay; and
- amends maps to the Development Plan Overlay and Public Acquisition Overlay.
