Marine Act 1988

SECTION 15 NOTICE

I, Diane Julie Bates, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Graeme Davis, Acting Manager of Operations Bays and Maritime Division, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. Between the hours and times detailed in Table 1 the operation of vessels (including anchoring, mooring or allowing a vessel to lie) excepting:
 - (a) Parks Victoria vessels;
 - (b) authorised vessels involved in 2010 Melbourne Rowing Week events;
 - (c) vessels engaged in the provision of rescue services for the 2010 Melbourne Rowing Week; and
 - (d) vessels under the direction of Parks Victoria,is prohibited on the waters of the Yarra River between the downstream edge of Spencer Street Bridge and the upstream edge of Sandridge Rail Bridge.

Monday 15 November	6.00 pm till 8.00 pm
Tuesday 16 November	6.00 pm till 8.00 pm
Friday 19 November	6.00 pm till 8.00 pm

2. Competitors in the 2010 Melbourne Rowing Week events held on 15 and 16 November are excluded from the requirement relating to the wearing of PFDs on recreational vessels as detailed in Schedule 5 made under Regulation 232 of the Marine Regulations 2009, providing all competitors are members of Rowing Victoria associated clubs or Life Saving Victoria.
3. Vessels involved in the 2010 Melbourne Rowing Week event are excluded from the requirement to operate a vessel at a speed not exceeding 5 knots within 50 meters of the water's edge as detailed in clause 3(a) of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
4. Life Saving Victoria vessels are excluded from the provisions of Clause 3(b) of Schedule 3 made under Notice No. 1 under section 15(2) of the **Marine Act 1988**.
5. At the completion of the event and/or as determined and announced by Parks Victoria, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
