## Marine Act 1988

### SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Darren Schultz, Building and Contracts Officer, Loddon Shire Council (Waterway Manager for the Loddon River at Bridgewater between Flour Mill Weir and Sweeneys Lane), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 12.01 am Saturday 4 December 2010 to 5.00 pm Sunday 5 December 2010, the waters of the Loddon River at Bridgewater, between the Calder Highway Bridge and Sweeneys Lane:
  - (a) are subject to a speed restriction of 5 knots for the purposes of conducting the Loddon Classic Fishing Competition; and
  - (b) the provisions as specified in Clause 5 of Schedule 62 of Notice No. 1 under section 15(2) of the **Marine Act 1988** do not apply for the duration of the Loddon Classic Fishing Competition.
2. at the completion of the event the waters will revert to the provisions of Schedule 62 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
