
Koornong Crescent, North Warrandyte – Tow Away Zone



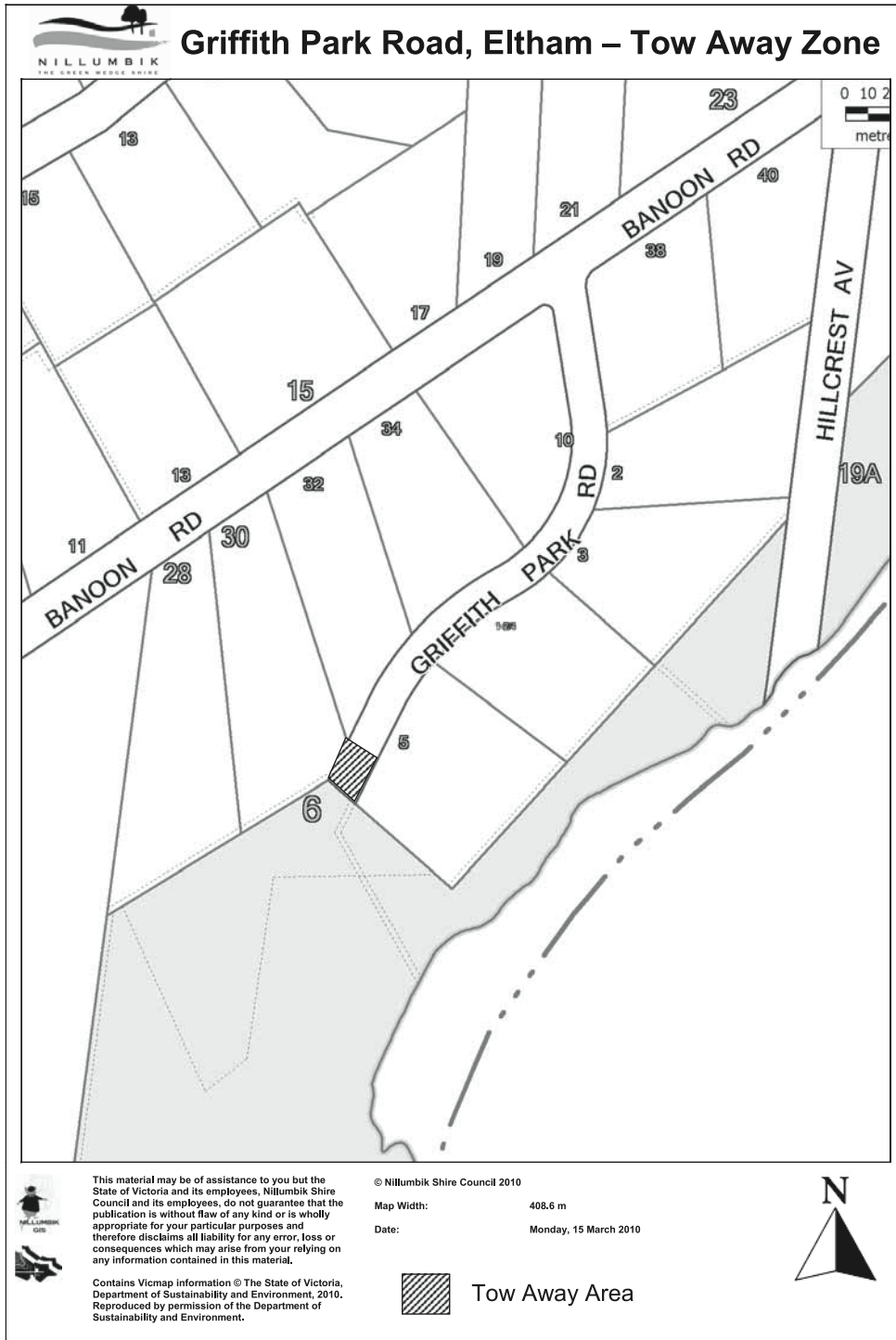

- Provide an exemption from Clause 520(1) of the requirement to attach and use a device that ensures the return of a shopping trolley to an area specifically designated for its storage, where the trolley is fitted with a baby capsule.

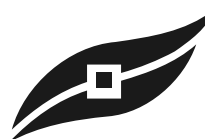

Exemption from Occupational Health and Safety Regulations 2007
Exemption Number H10/03866

Purpose

To exempt the employer Ford Motor Company of Australia Limited and their Ford Customer Service Division (FCSA), from the requirement that they must not use unlicensed employees to do high risk work, specifically, to hold an Order-Picking Fork-Lift Truck (Demag Crane) licence to perform high risk work.

Definition

In this exemption ('the Employer') means Ford Motor Company of Australia Limited.

Background

In undertaking their duties, the employer uses employees to perform a number of tasks which require them to hold an Order-Picking Fork-Lift Truck (Demag Crane) licence under the Occupational Health and Safety Regulations 2007.

Regulations

Regulations 3.6.2 of the Occupational Health and Safety Regulations 2007 states:

'An employer must not allow an employee to do any such work unless –

- a) the employee holds an appropriate high risk work licence in relation to that work'.

Exemption

Under regulation 7.2.2 of the Occupational Health and Safety Regulations 2007, I exempt the employer from Regulation 3.6.2 only in respect of the requirement for its employees to hold a Order-Picking Fork-Lift Truck (Demag Crane) licence, for the type of work described below, and subject to the prescribed conditions of this exemption.

2. This exemption shall apply from the period commencing 8 October 2010, or unless revoked or amended by the Victorian Workcover Authority (VWA) in writing.
3. In order for employees to operate Order-Picking Fork-Lift Truck (Demag Crane) under this exemption, the following conditions shall be met:
 - a. All employees shall hold a FCSA internal Permit DM before they are able to operate an Order-Picking Fork-Lift Truck (Demag Crane).
 - b. The training and assessment package to be used is based upon the National Assessment Instrument for Order-Picking Fork-Lift Truck and the FCSA Safe Work Procedures (SWP) numbered C555WD019 and C555WD016.
 - c. Each FCSA employee who is required to operate the Order-Picking Fork-Lift Truck (Demag Crane) is required to be trained and assessed against the training assessment package outlined above.

- d. That the training undertaken by employees the subject of this exemption will be completed within 6 months from the granting of this exemption.
- e. The Employer will provide training to all new employees who will be required to operate the Order-Picking Fork-Lift Truck (Demag Crane) in FCSA and in E, F and G zones of the plant.
- f. The Employer will provide on going training, against the training assessment package, to all those employees who will be required to operate the Order-Picking Fork-Lift Truck (Demag Crane) and that this training is in accordance with the obligations placed on the Employer under the **Occupational Health and Safety Act 2004**, Section 21(2) (e), and record that training and assessment verification on their personnel file.
- g. The training and assessment records will be retained by the Employer for reference and the VWA will audit these records from time to time at its discretion to ensure that the above conditions are observed.

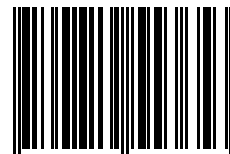
