Crown Land (Reserves) Act 1978

CROWN LAND (RESERVES) (PORTARLINGTON PUBLIC FORESHORE RESERVE) (EXTENSION OF APPLICATION) REGULATIONS 2010

I, Rodney Warren, Statewide Program Leader, Public Land Services, Statewide Services Division, as delegate of the Minister for Environment and Climate Change, make the following Regulations.

1. Objectives

The objectives of these Regulations is to extend the Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010 to apply to the Crown land reserves listed in the Schedule hereunder to ensure the care, protection and management of those reserves.

2. Authorising provision

These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

3. Commencement

These Regulations come into operation on the date they are published in the Victorian Government Gazette.

4. Extension of application of the Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010.

The Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010 are extended to apply to the Crown land reserves listed in the Schedule, being reserved lands managed by the Committee of Management of the Portarlington Public Foreshore Reserve.

5. Construction of reference to the reserve in the Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010.

The Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010, which have been extended by Regulation 4, apply to a reserve listed in the Schedule, as if a reference in those Regulations to the reserve were a reference to that reserve.
