**Marine Act 1988**

## SECTION 15 NOTICE

I, Diane Julie Bates, the Director Maritime Safety (as delegate of the Director, Transport Safety) on the recommendation of Graeme Davis, Acting Manager, Marine Operations, Bays and Maritime, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under subsection 15(1) of the **Marine Act 1988** of the following temporary amendments to Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** that:

1. Between the hours of 10.00 am on Saturday 27 November 2010 and 4.00 pm on Saturday 27 November 2010, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Yarra Head Regatta, vessels owned and operated by Parks Victoria and vessels authorised by Parks Victoria, is prohibited on all the waters of the Yarra River between an imaginary line from the downstream edge of the VRA Landing to the upstream edge of Federation Wharf, and upstream to the Victoria Street Bridge.
2. Rowing vessels involved in the Yarra Head Regatta event are excluded from the requirement to wear personal floatation devices as detailed in Schedule 5, made under Regulation 232 of the Marine Regulations 2009.
3. Vessels involved in the Yarra Head Regatta event are excluded from the requirement to operate a vessel at a speed not exceeding 5 knots within 50 meters of the waters edge as detailed in clause 3(a) of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
4. Between the hours of 9.00 am on Saturday 27 November 2010 and 6.00 pm on Saturday 27 November 2010, PWC operated by Life Saving Victoria are excluded from the provisions of Clause 3(b) in Schedule 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
5. At the completion of the event the waters of the Yarra River will revert to the normal provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
