Notice of Approval of Amendment

Amendment C78

The Minister for Planning has approved Amendment C78 to the Stonnington Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment introduces and applies a new local planning policy at Clause 22.19 and a new Schedule 7 to the Design and Development Overlay at Clause 43.02, which provide interim built form guidance for the Prahran/South Yarra and Windsor Activity Centre until 31 October 2012. The Amendment also makes associated changes to the Local Planning Policy Framework at Clauses 21.01, 21.04, 22.02 and the Schedule to 34.02 of the Planning Scheme.
