Road Safety Act 1986

ORDER UNDER SECTION 98 ROAD SAFETY ACT 1986 EXTENDING PROVISIONS TO THE CAMPUS WIDE PARKING FACILITIES AT MONASH UNIVERSITY, CLAYTON, CAULFIELD AND GIPPSLAND CAMPUSES

I, Steve Brown, Executive Director, VicRoads Regional Services, delegate of the Minister under section 98 of the **Road Safety Act 1986**, by this Order extend the application of:

- (a) sections 59, 64, 65, 76, 77, 85–90 and 100 of the Act; and
- (b) the Road Safety Road Rules 2009; and
- (c) Parts 8 and 9 and Schedules 6 and 7 of the Road Safety (General) Regulations 2009

to the following locations:

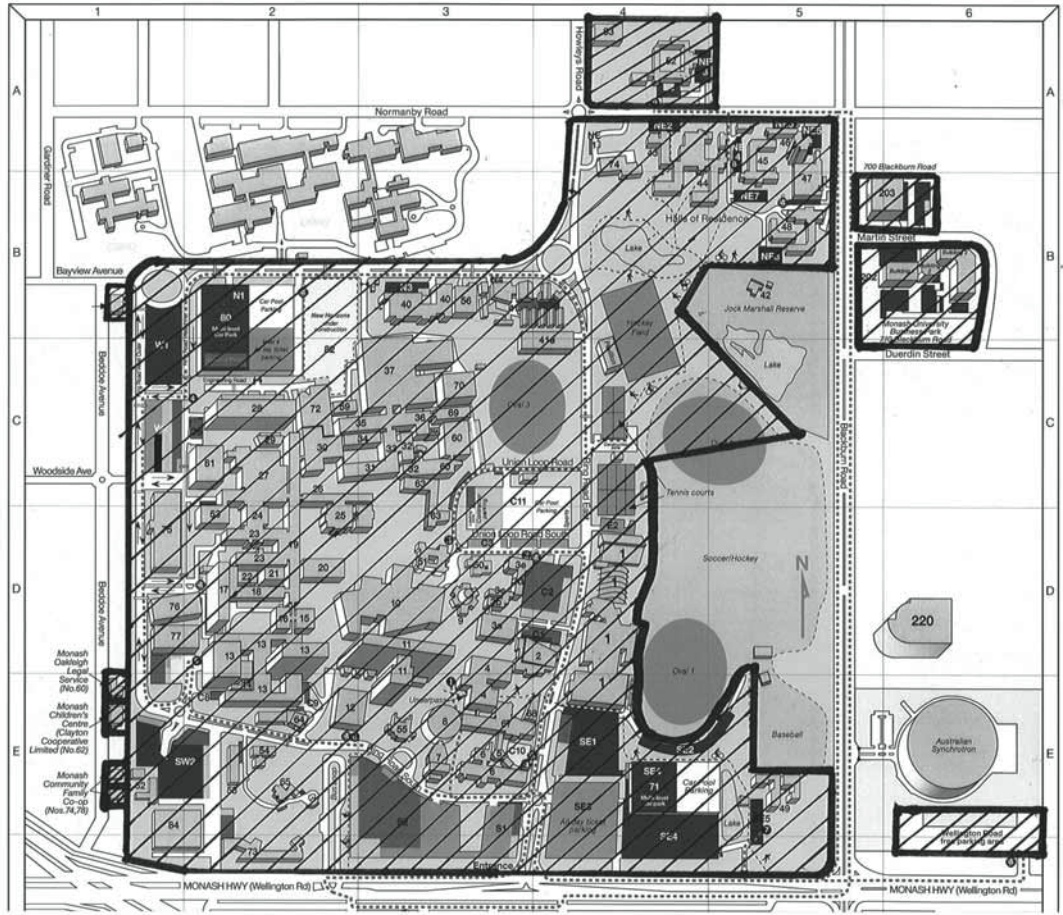
- (d) Monash University Clayton Campus, particulars of which are shown hatched on attached Plans 1A and 1B; and
- (e) Monash University Caulfield Campus, particulars of which are shown hatched on attached Plans 2A, 2B and 2C; and
- (f) Monash University Gippsland Campus (excluding Northways Road and McDonald Way), particulars of which are shown hatched on attached Plan 3.

The Order under section 98 of the Act in relation to the Monash University Gippsland Campus, published in Government Gazette G31 on 30 July 2009, is revoked.

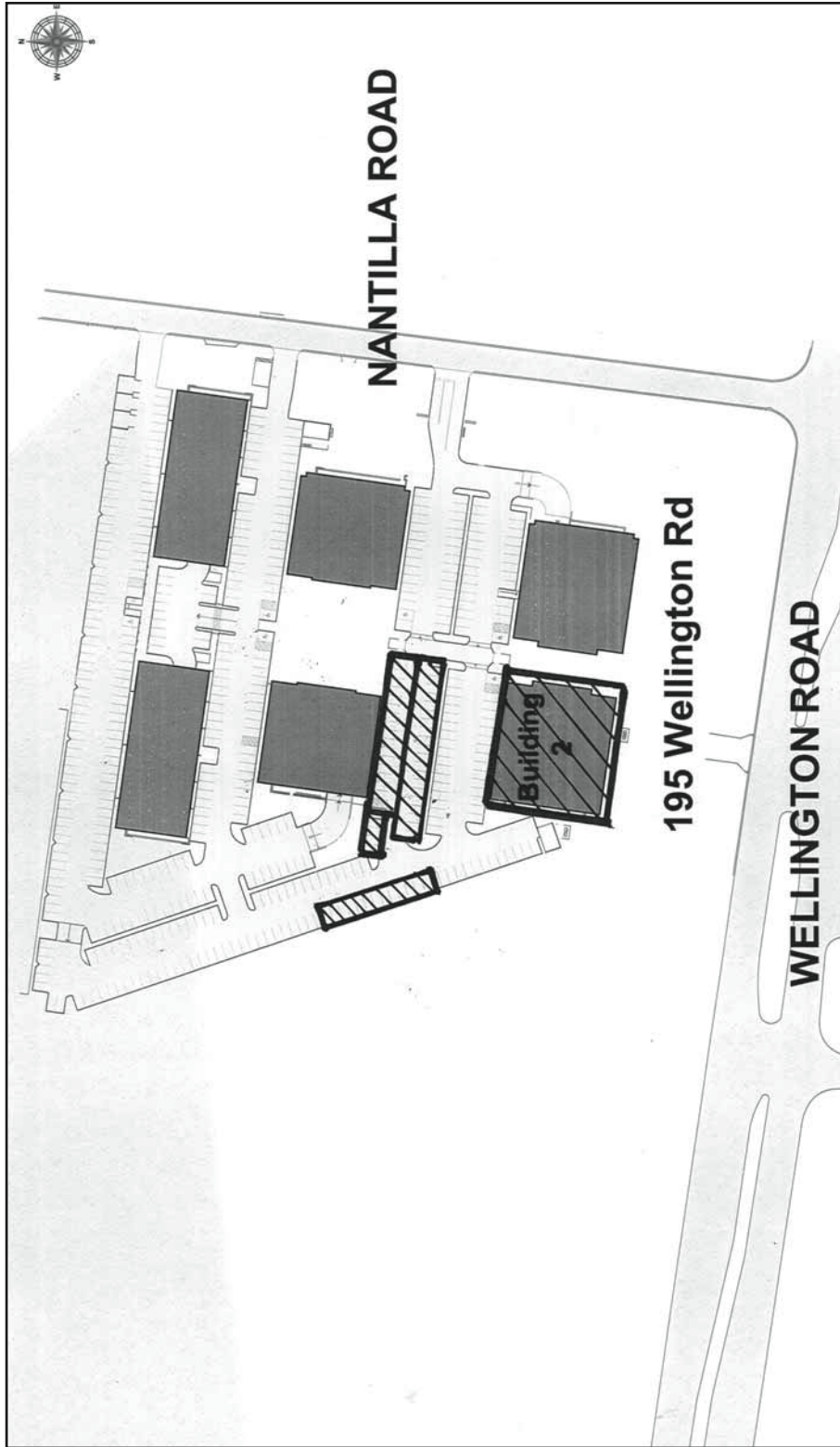

Monash University Clayton campus

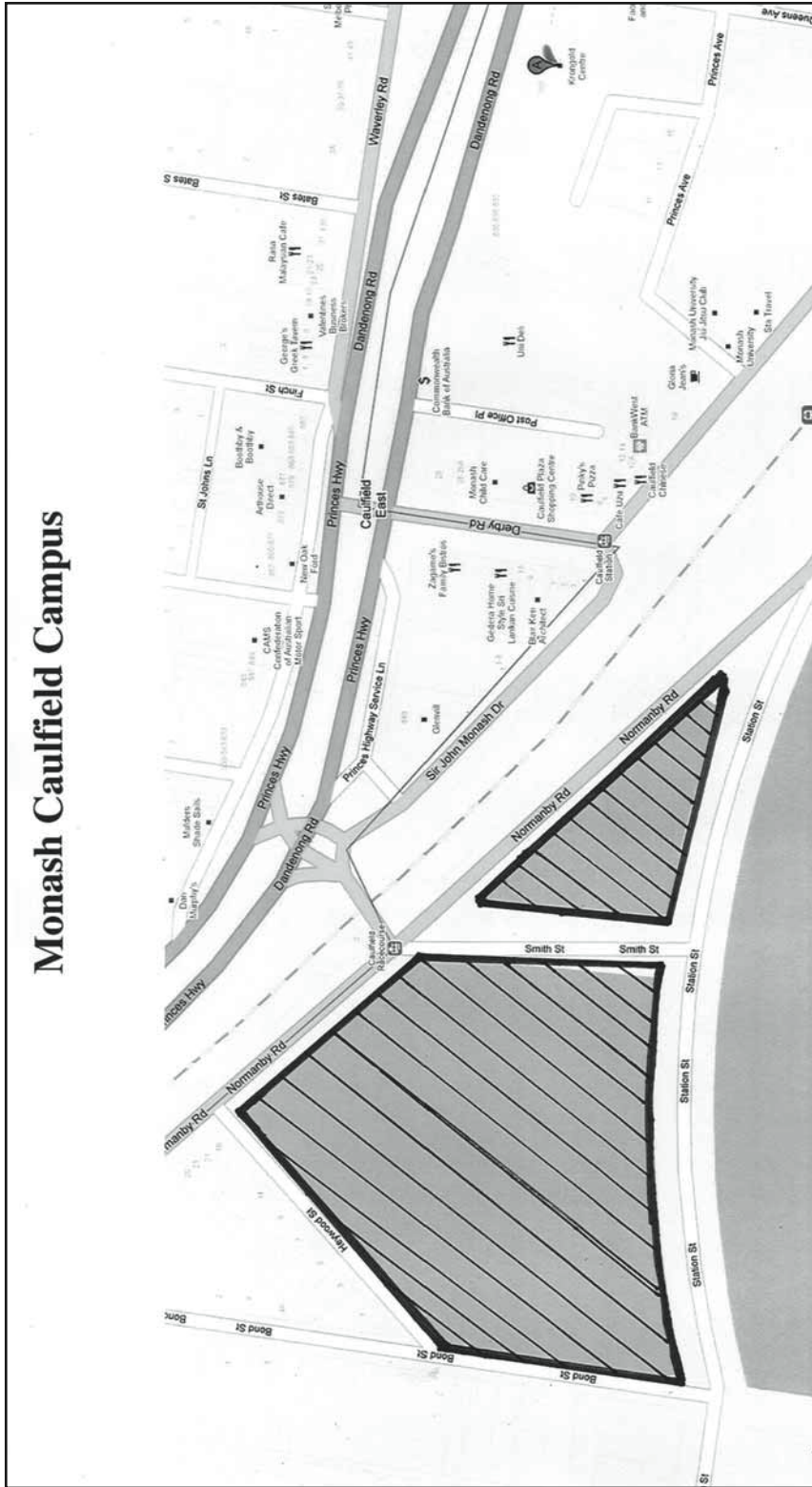


PLAN 1B ATTACHED TO ORDER UNDER SECTION 98 ROAD SAFETY ACT 1986

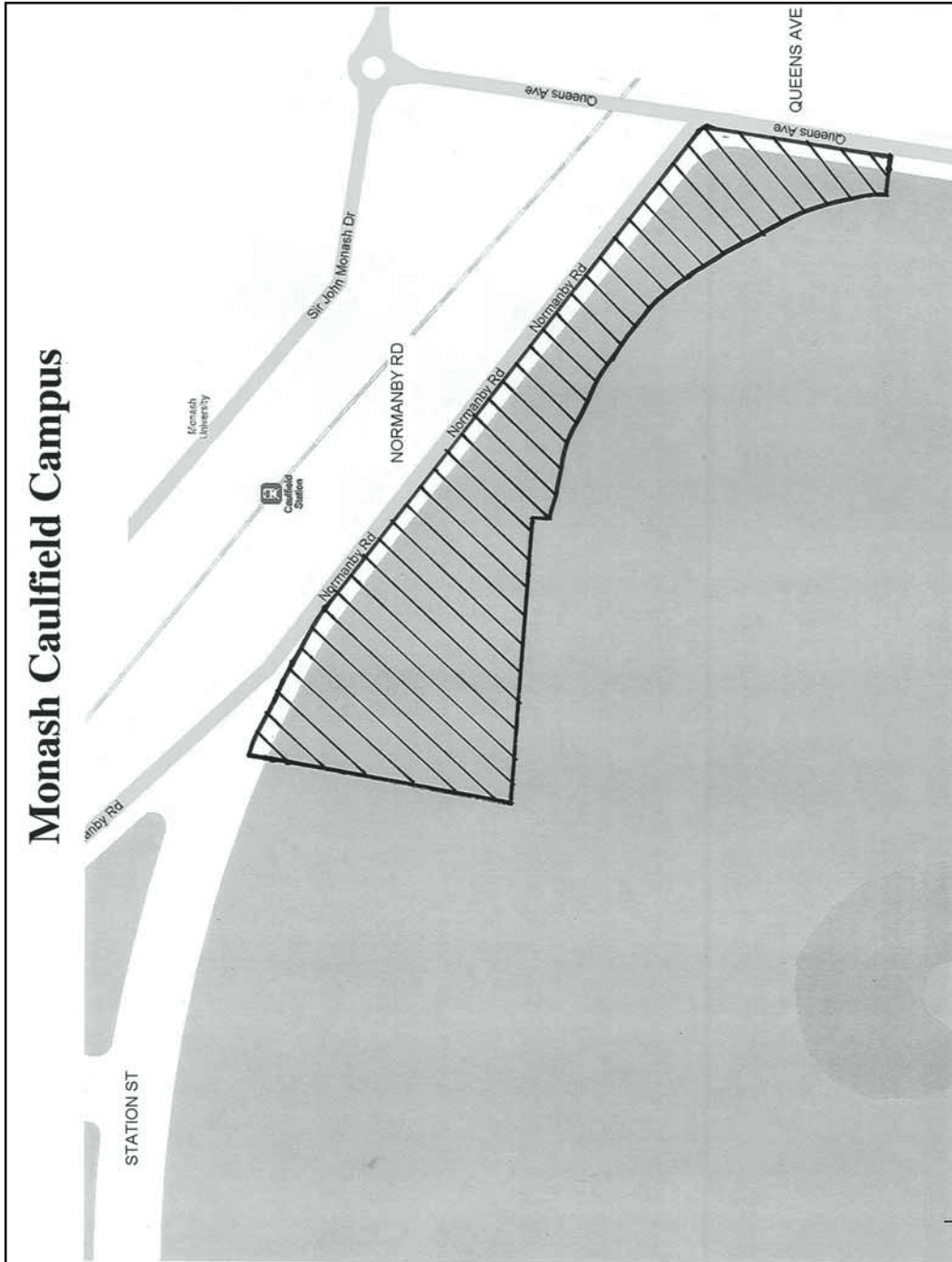


PLAN 2B ATTACHED TO ORDER UNDER SECTION 98 ROAD SAFETY ACT 1986
