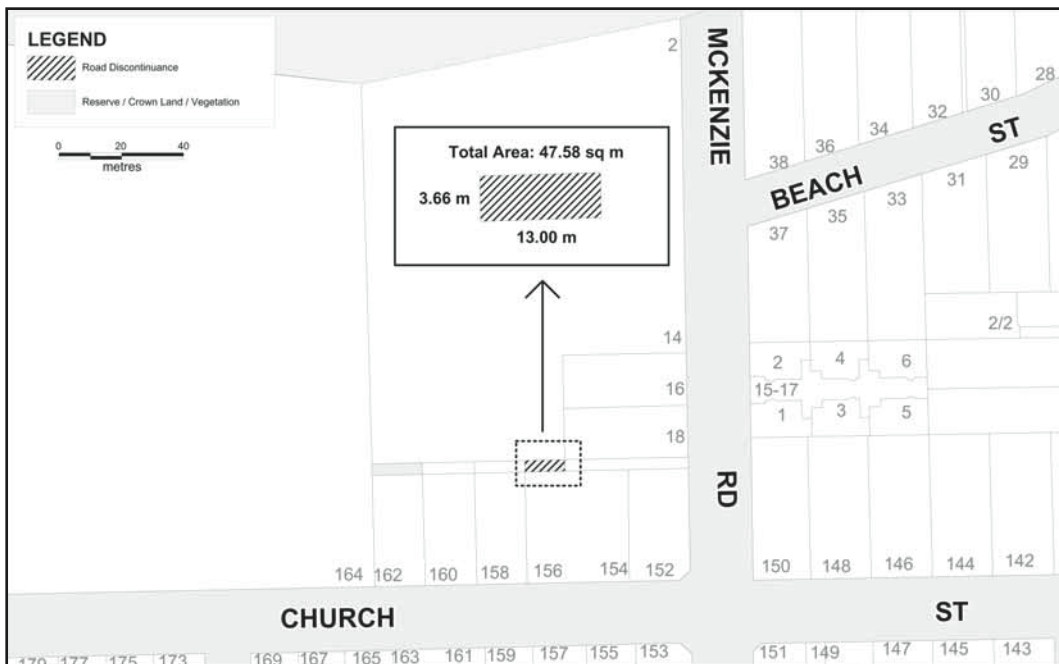

The Greater Geelong City Council has prepared Amendment C222 to the Greater Geelong Planning Scheme.

In accordance with section 8A(3) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the Greater Geelong Council as planning authority to prepare the Amendment.

The land affected by the Amendment is properties fronting Newcombe, Brown, Fenwick and Harding Streets within the Portarlington Town Centre.

The Amendment proposes to:

- rezone the council owned car park at 43–45 Fenwick Street, Portarlington, from Residential 1 to Business 1 zone;
- correctly align the Business 1/Residential 1 zone boundary with title boundaries of those properties south of Newcombe Street, west of Harding Street;
- extend the Design and Development Overlay 21 to include the Study Area of the Portarlington Urban Design Framework; and
- amend the existing Design and Development Overlay Schedule 21 to include recommendations of the adopted Portarlington Urban Design Framework.

Exemption from Occupational Health and Safety Regulations 2007
Exemption Number H10/02137

Purpose

To exempt those Employers listed in the table below from the requirement that they must not use unlicensed employees to do high risk work, specifically, to hold a Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) licence to perform high risk work.

Definition

In this exemption ('the Employer') means those listed in the table below.

Background

In undertaking their duties, the employer uses employees to perform a number of tasks which require them to hold a Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) licence under the Occupational Health and Safety Regulations 2007.

Regulations

Regulations 3.6.2 of the Occupational Health and Safety Regulations 2007 states:

'An employer must not allow an employee to do any such work unless –

- a) the employee holds an appropriate high risk work licence in relation to that work'.

Exemption

Under regulation 7.2.2 of the Occupational Health and Safety Regulations 2007, I exempt the employer from Regulation 3.6.2 only in respect of the requirement for its employees to hold a Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) licence, for the type of work described below, and subject to the prescribed conditions of this exemption.

I am satisfied that the work as described can be performed as safely by a person who does not hold a licence as it can be performed by a person who holds such a licence, provided that there is adherence to the prescribed conditions of this exemption.

Type of Work

The use of the Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) that are configured with a container lifting attachment with a twist lock mechanism to load, unload, move and store shipping containers at the Employer locations as listed in the table below.

Conditions

This exemption is subject to the conditions listed below:

1. This exemption is granted to the Employer, and shall only apply to employees operating Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) that are configured with a container lifting attachment at the Employer locations as listed in the table below.
2. This exemption shall apply from the period commencing 15 November 2010, or unless revoked or amended by the Victorian Workcover Authority (VWA) in writing.
3. In order for employees to operate Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) that are configured with a container lifting attachment with a twist lock mechanism under this exemption, the following conditions shall be met:
 - a. A training assessment package was developed under the auspice of the Victorian Transport Association using material supplied by Toll Shipping, Seacon Carriers Pty Ltd and M.T.B. Engineering Pty Ltd.
 - b. Each Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) that are configured with a container lifting attachment, the operator is required to be trained and assessed against the training assessment package.

- c. That the training undertaken by employees the subject of this exemption will be completed within six months from the granting of this exemption.
- d. The Employer will provide training to all new employees who will be required to operate a Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) that are configured with a container lifting attachment.
- e. The Employer will provide on going training, against the training assessment package, to all those employees who will be required to operate a Non-Slewing Mobile Cranes (Greater Than 3 Tonnes) that are configured with a container lifting attachment and that this training is in accordance with the obligations placed on the Employer under the **Occupational Health and Safety Act 2004**, section 21(2)(e), and record that training and assessment verification on their personnel file.
- f. If a reach stacker is configured with hooks, the Employer must ensure that where lifting slings are used to lift open top containers, the reach stacker becomes a non-Slewing mobile crane and must comply with AS 1418.5 or AS 1418.19 or equivalent international standard and that the operator needs to hold a high risk work licence for a non-slewing mobile crane (CN) as specified Occupational Health and Safety Regulations 2007, Regulation 3.6.1 Requirement to hold a licence and Regulation 3.6.2 Employer must not use unlicensed employees to do high risk work.
- g. The training and assessment records will be retained by the Employer for reference and the VWA will audit these records from time to time at its discretion to ensure that the above conditions are observed.

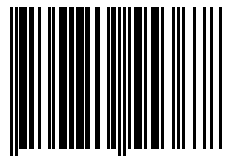
