MAJOR SPORTING EVENT ORDER – KEY CRICKET MATCHES TO BE PLAYED FROM 2010 TO 2015

Order in Council

The Governor, with the advice of Executive Council, under section 7 of the **Major Sporting Events Act 2009** makes a major sporting event order in relation to key cricket matches to be played from 2010 to 2015, as follows:
