## Cemeteries and Crematoria Act 2003

### SECTION 40(2)

#### Declaration that Cemetery Trust Fees are Increased

I, Bryan Crampton, as Delegate of the Secretary to the Department of Health for the purposes of section 40(2) of the **Cemeteries and Crematoria Act 2003**, declare that all cemetery trust fees of \$50 or more will increase by 1.8 per cent in accordance with movements in the All Groups Consumer Price Index number (for Melbourne) as published by the Australian Bureau of Statistics, except for the relevant fees of those trusts listed on the attached schedule (A) which will increase by the amount shown. This declaration will take effect on 1 July 2010.
