### APPOINTMENT OF DELEGATE TO THE BOARD OF MANSFIELD DISTRICT HOSPITAL

#### Instrument of Appointment

I, Daniel Andrews, Minister for Health, under section 40C(1) of the **Health Services Act 1988**, appoint Michael Ellis as a delegate to Mansfield District Hospital board of management.

The appointment is made on the following terms and conditions –

- 1. Appointment arrangements**  
The appointment is part-time.
- 2. Period of Appointment**  
The appointment is for a period of 12 months from the date of publication of this instrument in the Government Gazette (both dates inclusive).
- 3. Revocation**  
Under section 40C(8) of the **Health Services Act 1988**, the Minister for Health may at any time revoke this appointment.
- 4. Payment Provisions**  
The delegate will be paid remuneration of \$30,000 per annum (exclusive of superannuation).
- 5. Superannuation Obligations**  
Superannuation obligations will be paid by the employer in accordance with the Commonwealth's **Superannuation Guarantee (Administration) Act 1992** (Cth).
- 6. Travel and personal expenses**  
The delegate will be reimbursed for reasonable travel and personal expenses in accordance with the Personal and Travelling Expenses Policy issued by the Department of Health in September 2009.
- 7. Leave arrangements**  
As the appointment is part-time, the delegate will not be entitled to paid leave of any kind.
