## Wildlife Act 1975

### WILDLIFE (CONTROL OF GAME HUNTING) NOTICE NO. 1/2010

I, Gavin Jennings, Minister for Environment and Climate Change, make the following Notice:

#### 1. Objectives

The objectives of this Notice are to –

- (a) prohibit absolutely the taking, destroying or hunting in Victoria of certain taxa of game duck during specified periods; and
- (b) set bag limits for the 2010 open season for game duck hunting.

#### 2. Authorising provision

This Notice is made under section 86 of the **Wildlife Act 1975**.

#### 3. Commencement

This Notice comes into operation on 20 March 2010 and expires on 14 June 2010.

#### 4. Definitions

Game duck means any taxa of duck prescribed as game for the purposes of the Wildlife (Game) Regulations 2001.

#### 5. Hunting of game duck prohibited

The taking, destroying or hunting of any taxa of game duck is prohibited:

- a) from 20 March 2010 until:
  - i) 7.10 am on that day east of the line of longitude at 146° 30' east; and
  - ii) 7.20 am on that day between the line of longitude at 146° 30' east and the line of longitude at 142° 30' east; and
  - iii) 7.30 am on that day west of the line of longitude at 142° 30' east; and
- b) during the period from 31 May 2010 to 14 June 2010.

#### 6. Bag limits for game duck

The bag limit for game ducks for any day during the open season is a maximum of five game ducks, including no more than one (1) Australasian (Blue Winged) Shoveler, plus an additional three (3) Australian Wood Ducks (Maned Duck).

#### 7. Contravention of Notice

A person must not contravene any part of this Notice.

Penalty: 25 penalty units.
