## Road Safety Act 1986

### EXEMPTION FOR THE PERSON PERFORMING A MOTORBIKE STUNT AT THE 2010 FORMULA 1 QANTAS AUSTRALIAN GRAND PRIX

#### 1. Declaration

I, Steve Brown, Executive Director Regional Services VicRoads, acting under section 99B(4) of the **Road Safety Act 1986** and on the application of Australian Grand Prix Corporation, declare that the provisions of the Road Safety Road Rules 2009 and the **Road Safety Act 1986** specified in Schedule 1 do not apply to the non-road activity specified in column 1 of Schedule 2 conducted on the highway specified in column 2 of Schedule 2 during the period specified in column 3 of Schedule 2, subject to the conditions set out in paragraph 2.

#### 2. Conditions

This exemption is subject to the following conditions –

- (1) The owner of the land on which the non-road activity is to be conducted must have consented to that activity.
- (2) The highway used for the non-road activity must be closed to traffic.
- (3) Except the provisions exempted by this notice and as set out in Schedule 1, all relevant safety requirements must be complied with including (without limitation) all provisions of the **Road Safety Act 1986**, the Road Safety Road Rules 2009, the **Road Management Act 2004** and the **Occupational Health and Safety Act 2004** and any regulations made under those Acts.
- (4) A copy of this notice must be produced on demand to any member of the police force or to any person who is an authorised officer under section 71 of the **Road Management Act 2004**.
- (5) Failure to comply with a condition specified in paragraph 2 does not invalidate the exemption given by this Notice.

#### Schedule 1

| Provisions of Road Safety Road Rules 2009 to which this exemption applies |  |
|---|--|
| Rule 20   | A driver must not drive at a speed over the speed-limit applying to the driver for the length of road where the driver is driving.                           |
| Provisions of Road Safety Act 1986 to which this exemption applies        |  |
| Section 64  | A person must not drive a motor vehicle at a speed or in a manner which is dangerous to the public, having regard to all the circumstances of the case.      |
| Section 65  | A person who drives a motor vehicle on a highway carelessly is guilty of an offence.   |
| Section 65A   | A person must not drive a motor vehicle in a manner which causes the motor vehicle to undergo loss of traction by one or more of the motor vehicle's wheels. |
| Section 68  | A person who on a highway drives or is in charge of a motor vehicle which is being used in a race or speed trial is guilty of an offence.                    |
