The Victorian Civil and Administrative Tribunal has considered an application, pursuant to section 83 of the **Equal Opportunity Act 1995**, by Peninsula Health. The application for exemption is to enable the applicant to advertise for and employ a male counsellor in its Family Violence Program (the exempt conduct).

Upon reading the material submitted in support of the application the Tribunal is satisfied that it is appropriate to grant an exemption from sections 13, 14, 100 and 195 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption, the Tribunal noted:

- The applicant conducts a Family Violence Program which aims to address the causes of and to provide counselling for those who perpetrate or are the victims of family violence and for members of families in which family violence occurs. The program includes a Behaviour Change segment for men who have been referred by Victoria Police for violence against women. It also includes a segment – the Out of Bounds segment – designed for the counselling of parents where there is adolescent violence in the home.
- The relevant State Government guidelines require that programs of this kind be co-facilitated by a man and a woman. This provides the appropriate role models, gender balance and diversity of views which will assist participants in the program.
- The applicant seeks this exemption to enable it to staff this program with a male counsellor. It currently has female counsellors who can staff the program. The male counsellor will also be able to give particular support to young males whom currently these programs find it difficult to engage.

The Tribunal hereby grants an exemption to the applicant from the operation of sections 13, 14, 100 and 195 of the **Equal Opportunity Act 1995** to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 24 March 2013.

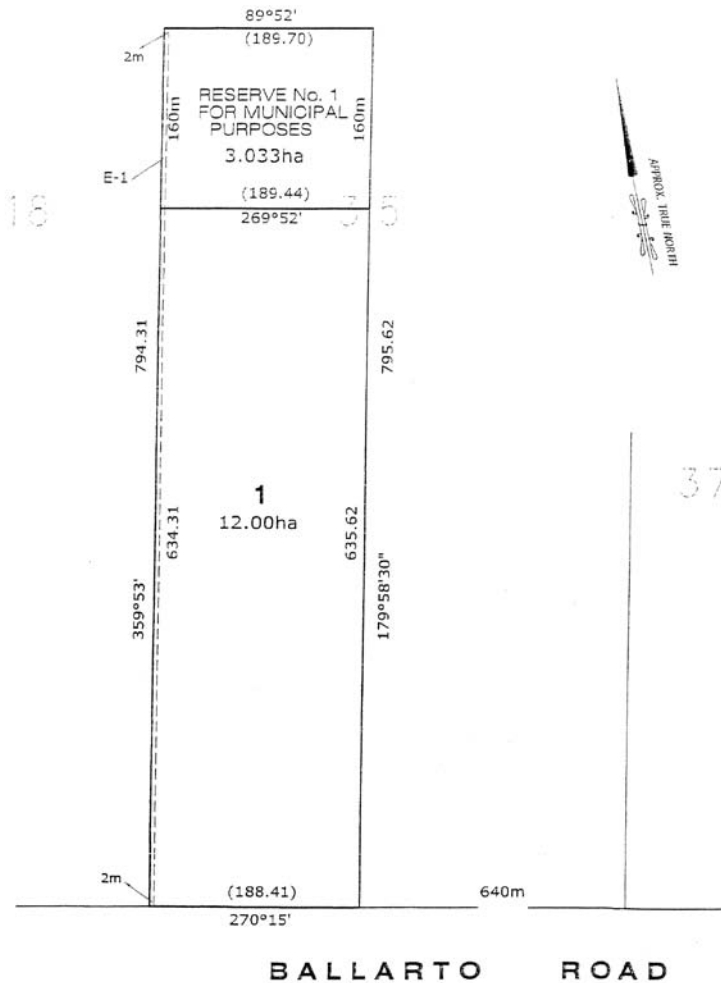

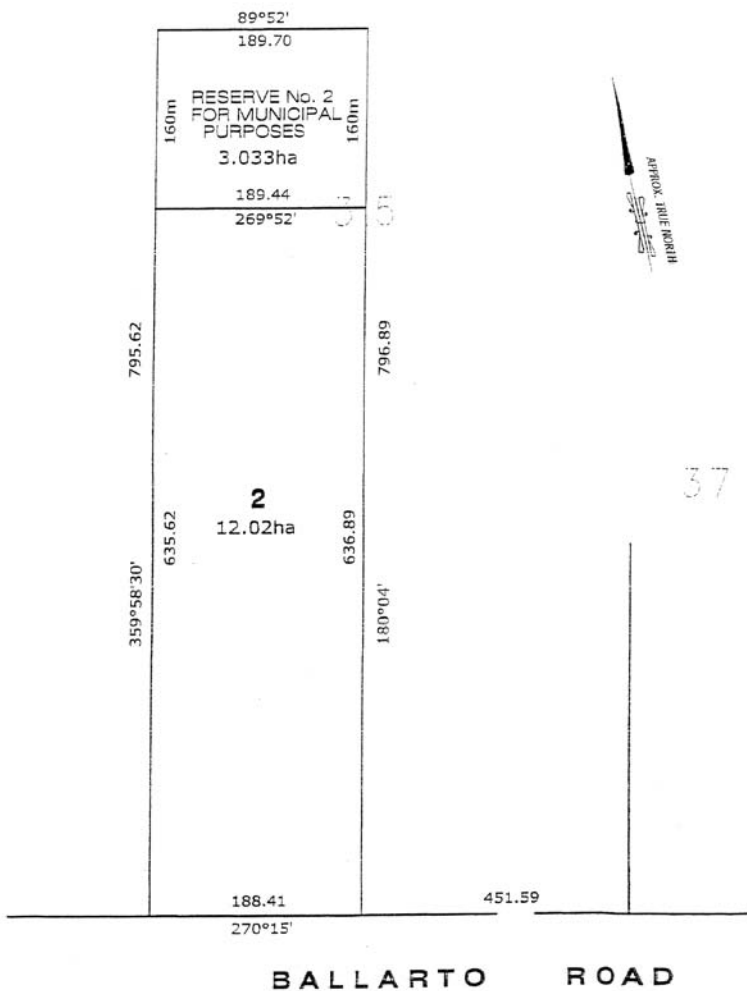

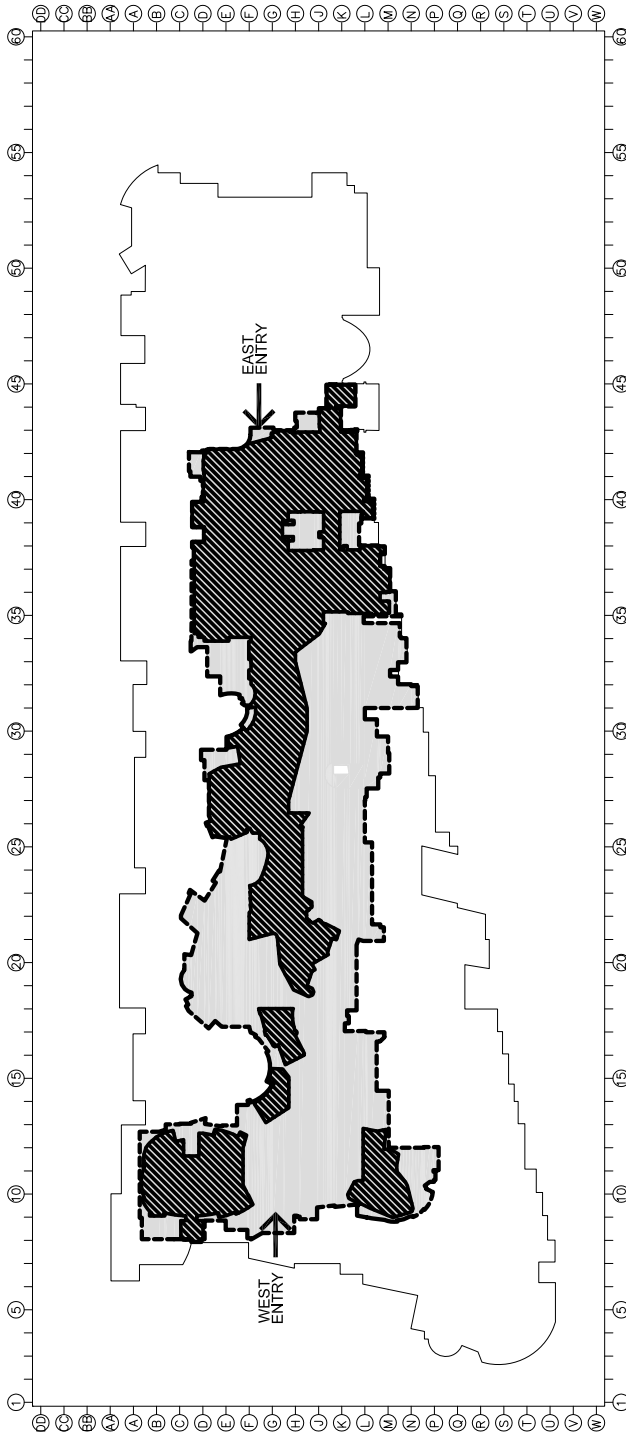

 - (C) the total number of gaming machines which are both operating in the mode referred to in sub paragraph (A) and from which winnings or accumulated credits in excess of \$2,000 may be paid out in cash as referred to in sub paragraph (B),must not exceed 1,000.
- (ii) a gaming machine located in an area specified by a notice under sections 62AB(4), 62AC(2) and 81AAB(2) of the **Casino Control Act 1991** referred to in section 3.2.3(1)(g) of the **Gambling Regulation Act 2003** may only operate in a mode where spin rate, bet limit, autoplay and note acceptors are unrestricted if that gaming machine may only be played in that mode by means of a card, Personal Identification Number (PIN) or similar technology which requires the player to nominate limits on time and net loss before play can commence; and
- (iii) the payment of winnings or accumulated credits in excess of \$2,000 may only be paid by cash if the winnings or credits are from one of the up to 1,000 machines specified in condition (i)(B). This provision regarding the payment of winnings by cash applies to the up to 1,000 machines specified in condition (i)(B) regardless of whether or not the machine:
 - (A) was also a machine capable of operating in a mode described in condition (i)(A); and
 - (B) was actually being played in exempt mode by means of card, PIN or similar technology at the time of the accumulation or payment of winnings as described in condition (ii).

MAIN CASINO LEVEL - GROUND FLOOR

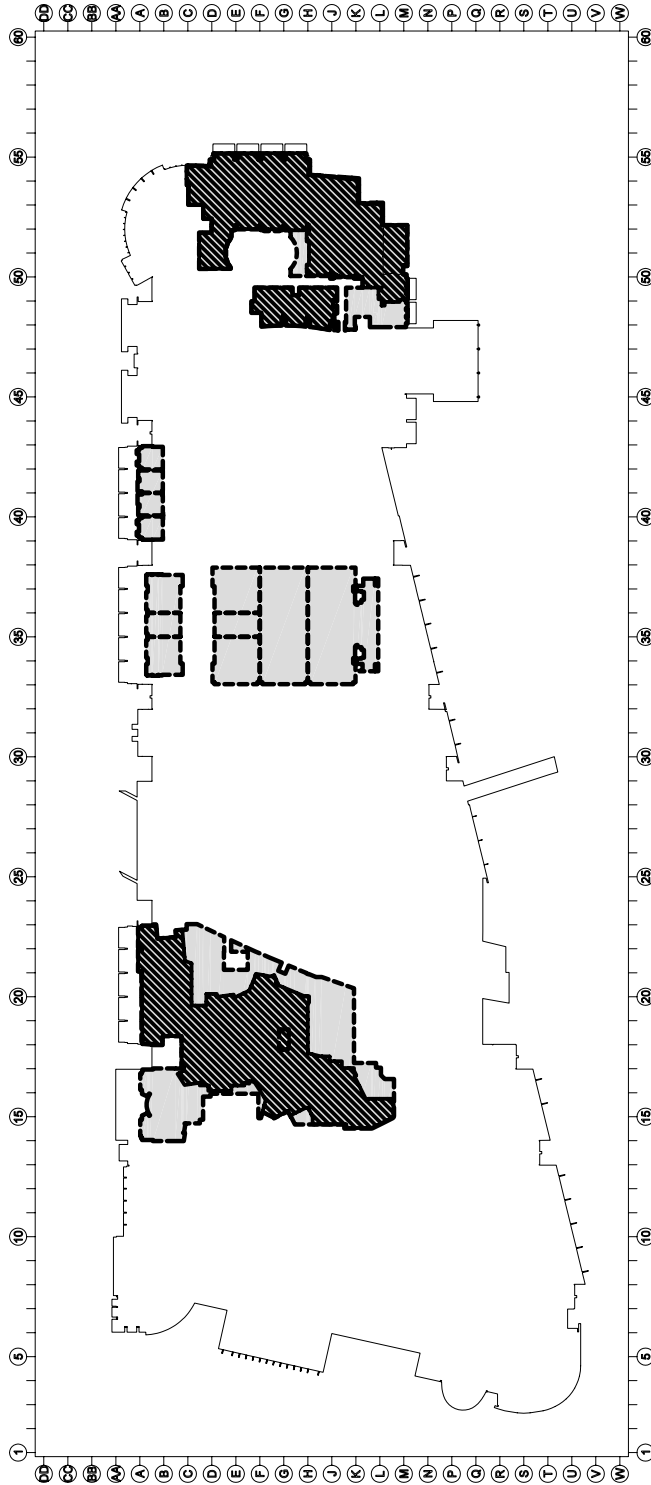

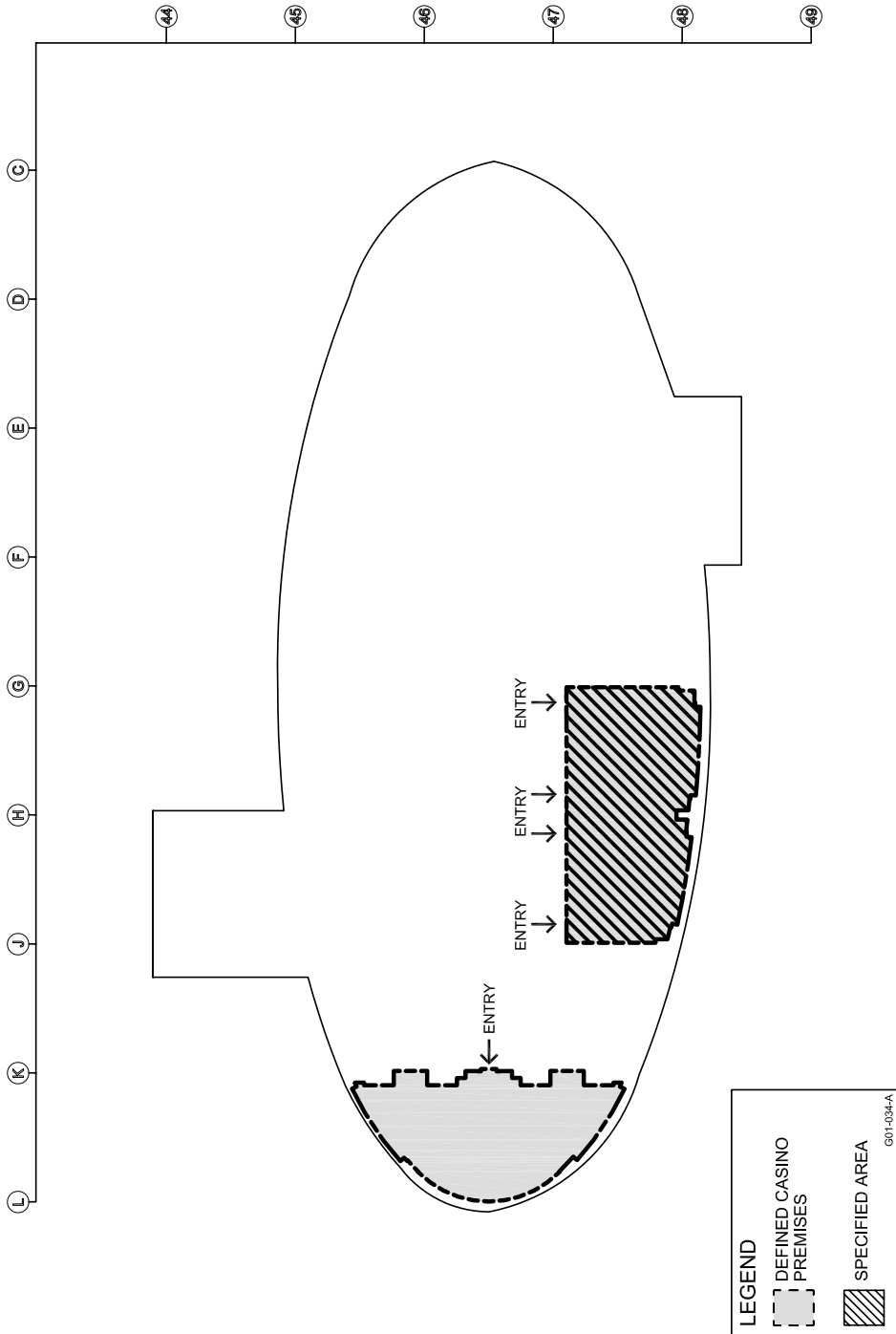

FISHERIES NOTICE NO. 4/2010

I, Anthony Hurst, Executive Director Fisheries Victoria and delegate of the Minister for Agriculture, make the following Fisheries Notice:

FISHERIES (WESTERN ABALONE ZONE) NOTICE NO. 4/2010

1. Title

This Notice may be cited as the Fisheries (Western Abalone Zone) Notice No. 4/2010.

2. Objectives

The objective of this Notice is to implement measures to rebuild the abalone fishery in the western zone.

3. Authorising provision

This Notice is made under section 152 of the **Fisheries Act 1995**.

4. Commencement

This Notice comes into operation on 1 April 2010.

5. Definitions

In this Notice –

shellfish means all species in the phylum mollusca except squid, octopus and cuttlefish;

substrate means any part of the sea bed and sub-soil lying beneath the waters;

the Act means the **Fisheries Act 1995**;

western abalone zone means all Victorian waters west of longitude 142°31' east.

6. Prohibitions

(1) For the purpose of section 67 of the Act, the taking or possession of the following fish is prohibited in the area described in Schedule 1 –

- (a) abalone and any other shellfish
- (b) sea urchins.

(2) Despite sub-clause (1) a person may possess abalone in the area described in Schedule 1 if the person is travelling by boat by the shortest practicable route from a point outside that area to the mouth of the Moyne River.

(3) For the purpose of section 114 of the Act, the use of commercial abalone equipment is prohibited in the area described in Schedule 1.

(4) A person must not collect any substrate from the area described in Schedule 1.
Penalty: 50 penalty units.

(5) This clause does not apply to a person authorised by the Secretary to undertake activities within the area described in Schedule 1.

7. Minimum size for abalone taken from the western abalone zone

For the purposes of the Act, the minimum size with respect to –

- (a) the taking of blacklip abalone from the western abalone zone is 13 centimetres;
or
- (b) the possession of blacklip abalone in, on or next to waters in the western abalone zone is 13 centimetres.

Note: There are offences in sections 68A and 68B of the Act relating to taking or possessing fish that are less than the minimum size specified in a fisheries notice. Various penalties apply. Minimum size offences apply to commercial and recreational fishers.

The minimum sizes fixed by clause 7 apply in addition to any minimum size limits established under the Fisheries Regulations 2009.

9. Closed seasons

- (1) For the purposes of section 67 of the Act, the closed season for all species of abalone in the waters specified in Column 1 of Schedule 2, is specified in Column 2 of the Schedule corresponding to those waters and applies to the persons or class of person specified in Column 3 of the Schedule corresponding to those waters.
- (2) For the purposes of section 67 of the Act, the taking or possession of any abalone from the waters specified in Column 1 of Schedule 2 during the period specified as the closed season for those waters in Column 2 of the Schedule by a person specified in Column 3 of the Schedule corresponding to those waters is prohibited.

Note: A failure to comply with this regulation is an offence under section 67(3) of the Act. A penalty of 100 penalty units or 6 months imprisonment or both applies.

10. Revocation

Unless sooner revoked, this Fisheries Notice will be automatically revoked on 31 March 2011.

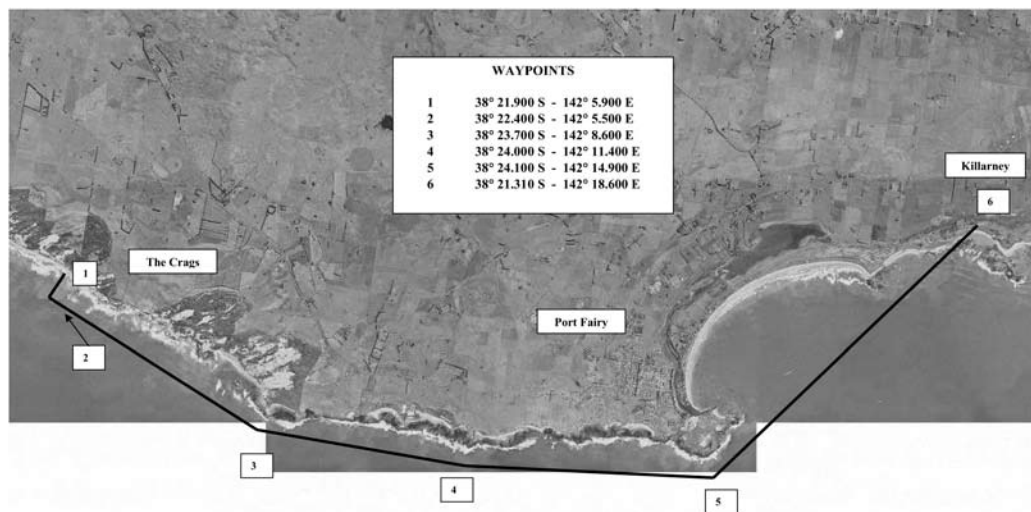
