FURTHER ABALONE QUOTA ORDER

I, Anthony Hurst, Executive Director Fisheries Victoria, as a delegate of the Minister for Agriculture, make the following Order under section 66D of the **Fisheries Act 1995** –

1. This Order applies for the period commencing on 1 April 2010 and ending on 31 March 2011 ('the quota period').
2. The total allowable catch for blacklip abalone in the eastern abalone zone for the quota period is 428.2 tonnes of unshucked blacklip abalone.
3. The total allowable catch for blacklip abalone in the central abalone zone for the quota period is 281.5 tonnes of unshucked blacklip abalone.
4. The total allowable catch for blacklip abalone in the western abalone zone for the quota period is 16 tonnes of unshucked blacklip abalone.
5. The total allowable catch for greenlip abalone in the central abalone zone for the quota period is 3.4 tonnes of unshucked greenlip abalone.
6. The total allowable catch for greenlip abalone in the western abalone zone for the quota period is 12.6 tonnes of unshucked greenlip abalone.
7. The quantity of fish comprising an individual blacklip abalone quota unit in the eastern abalone zone for the quota period is 931 kilograms of unshucked blacklip abalone.
8. The quantity of fish comprising an individual blacklip abalone quota unit in the central abalone zone for the quota period is 414 kilograms of unshucked blacklip abalone.
9. The quantity of fish comprising an individual blacklip abalone quota unit in the western abalone zone for the quota period is 57 kilograms of unshucked blacklip abalone.
10. The quantity of fish comprising an individual greenlip abalone quota unit in the central abalone zone for the quota period is 100 kilograms of unshucked greenlip abalone.
11. The quantity of fish comprising an individual greenlip abalone quota unit in the western abalone zone for the quota period is 900 kilograms of unshucked greenlip abalone.

This Order commences on 1 April 2010 and remains in force until 31 March 2011.
