14/2010 **Victoria University Act 2010**

- 11/2010 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 (2) Section 20(2) comes into operation on 1 January 2011.
- 12/2010 (1) Subject to subsection (3), this Act, other than section 8, comes into operation on a day or days to be proclaimed.
 (2) Subject to subsection (4), section 8, comes into operation on a day to be proclaimed.
 (3) If a provision of this Act, other than section 8, does not come into operation before 1 December 2010, it comes into operation on that day.
 (4) If section 8 does not come into operation before 1 August 2013 it comes into operation on that day.
- 13/2010 (1) This Part and Parts 3 and 5 come into operation on the day after the day on which this Act receives the Royal Assent.
 (2) The remaining provisions of this Act, including the Schedule, come into operation on 1 July 2010.
- 14/2010 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 (2) If a provision of this Act does not come into operation before 1 January 2011, it comes into operation on that day.
