Marine Act 1988 SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Vincent Wright, Manager of Operations, Bays and Maritime Division, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. between the hours of 9.00 am and 4.00 pm Saturday 3 April 2010, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding those vessels involved with filming activities, Parks Victoria vessels and vessels under the direction of Parks Victoria, is prohibited on the waters of the Yarra River contained within:
 - (a) the downstream edge of the Southgate Floating Landing to the northern downstream edge of the Southgate Pedestrian Bridge, and
 - (b) the downstream edge of the Flinders Walk Floating Walkway to the southern upstream edge of the Southgate Pedestrian Bridge,
2. personnel involved in filming activities are excluded from the provisions of Clause 3(a) of Schedule 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988**,
3. at the completion of the event and/or as determined and announced by Parks Victoria, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
