## Marine Act 1988

### SECTION 15 NOTICE

I, Diane Julie Bates the Director of Marine Safety, on the recommendation of Wayne Hill, Acting Manager Operations, Bays and Maritime Division, Parks Victoria (the Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. for the times and dates detailed in Table 1, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels owned and operated by Parks Victoria and vessels associated with the Melbourne Main Sewer Replacement Project is prohibited on all the waters of the Yarra River as detailed below in Table 2;

- (ii) A line extending from a point 37° 49' 26.3916" S, 144° 57' 01.9459" E; to a point 37° 49' 25.4175" S, 144° 56' 50.2535" E;
- (iii) A line extending from a point 37° 49' 25.4175" S, 144° 56' 50.2535" E; to a point 37° 49' 22.0012" S, 144° 56' 49.5419" E;
- (iv) A line extending from a point 37° 49' 22.0012" S, 144° 56' 49.5419" E to a point 37°49' 23.5429" S, 144° 57' 02.4362" E.
