Water Act 1989

PUBLIC NOTICE

Pursuant to Section 287ZE of the **Water Act 1989** (Vic), Western Water gives notice that it proposes to amend Water Restriction By-Law 08/01 ('the By-Law'). The purpose of the proposed amendment is to replace 'Stage 3 (known as Stage 3a)' water restrictions with Stage 3 water restrictions and to relax the restrictions that apply to residential and commercial garden watering, public garden watering and sportsground watering in its water supply service area.

Currently, residential and commercial gardens, public gardens and sportsgrounds (as defined in the By-Law) may only be watered:

- using specified watering methods; and
- during specified times of the day; and
- on two specified days of the week

as set out in Schedule 2, Part B of the By-Law.

The proposed amendments to the By-Law would increase the number of days on which residential and commercial gardens, public gardens and sportsgrounds may be watered by allowing watering to occur on alternate days, according to a system by which:

- properties with an odd street number may water on odd-numbered days of any month;
- properties with an even street number and properties without a street number may water on even-numbered days of any month; and
- any property may water on the 31st day of any month.

The specified watering methods and the specified times of the day during which watering may occur would remain unchanged.

A copy of the By-Law containing the proposed amendments may be inspected, free of charge, at the following locations:

- the offices of Western Water during ordinary business hours;
- the Western Water website.

Western Water invites submissions on the proposed amendments to the By-Law. Any person who is affected by the proposed amendments to the By-Law may make a submission on the proposed amendments to Western Water. Submissions must be made in writing (whether by means of electronic communication or otherwise) and must be received by the Authority within one calendar month of the publication of this notice.
