CASEY PLANNING SCHEME

Notice of Approval of Amendment

Amendment C119

The Minister for Planning has approved Amendment C119 to the Casey Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment modifies the schedule to Clause 81.01 to introduce the Cranbourne East Precinct Structure Plan (including the Cranbourne East Native Vegetation Precinct Plan) and the Cranbourne East Precinct Structure Plan Development Contributions Plan as incorporated documents, applies the UGZ2 and DCPO10 within the Cranbourne East Precinct Structure Plan area (PSP area), rezones the Collison Estate from LDRZ to the UGZ, applies an EAO and PAO3 to various sites within the PSP area, deletes DPO1 and part of the LSIO to land within the PSP area, reduces the extent of the HO125 and HO151 boundary, updates the schedules to the B1Z, Clause 43.01, Clause 52.01, Clause 52.16, Clause 52.17 and Clause 66.04 and amends Clauses 21.03, 21.14 and 22.07.
