Crown Land (Reserves) Act 1978

CROWN LAND (RESERVES) (PORTARLINGTON PUBLIC FORESHORE RESERVE) (EXTENSION OF APPLICATION) REGULATIONS 2010

I, Vivienne Clare, Acting Director, Public Land Management and Use – Public Land Division, as delegate of the Minister for Environment and Climate Change, make the following Regulations.

1. Objective

The objective of these Regulations is to extend the Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010 to apply to the Crown land reserves listed in the Schedule to provide for the care, protection and management of those reserves.

2. Authorising provision

These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

3. Commencement

These Regulations come into operation on the date they are published in the Victorian Government Gazette.

4. Extension of application of the Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010

The Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010 are extended to apply to the Crown land reserves listed in the Schedule, being reserved lands managed by the committee of management of the Portarlington Public Foreshore Reserve.

5. Construction of reference to the reserve in the Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010.

The Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010, apply to a reserve listed in the Schedule, as if a reference in the Crown Land (Reserves) (Portarlington Public Foreshore Reserve) Regulations 2010 to 'the reserve' were a reference to the reserve listed in the Schedule.

SCHEDULE

RESERVES TO WHICH THESE REGULATIONS APPLY

1. Allotment 128A, Parish of Paywit, being the land permanently reserved for Public Purposes by Order in Council dated 27 September 1949, published in the Government Gazette on 5 October 1949, Page 5630 and land which was permanently reserved for Public Purposes by Order in Council dated 26 May 1873, published in the Government Gazette on 13 June 1873, Page 1059. (0701553 and 0701973).
2. Allotment 43, Section 1, Parish of Paywit, being the land permanently reserved for Public Purposes by Order in Council dated 26 May 1873, published in the Government Gazette on 13 June 1873, Page 1059. (0701553).
3. Allotment 44, Section 1, Parish of Paywit, being the land permanently reserved for Public Purposes by Order in Council dated 12 May 1953, published in the Government Gazette on 20 May 1953, Page 2518. (0701553).
