Crown Land (Reserves) Act 1978

CROWN LAND (RESERVES) (KARDINIA OVAL RESERVE) (REVOCATION) REGULATIONS 2010

I, Vivienne Clare, Acting Director, Public Land Management and Use – Public Land Division, as delegate of the Minister for Environment and Climate Change, make the following Regulations.

1. Objective

The objective of these Regulations is to revoke –

- (a) the Regulations for the Care, Protection, and Management of Kardinia Park and the Collection and Receipt of Tolls, Entrance Fees, or Charges as made on 26 September 1930 and published in the Government Gazette on 1 October 1930, page 2602; and
- (b) the Additional Regulation for the Care, Protection, and Management of the ‘Kardinia Park’, Geelong made on 24 April 1941 and published in the Victoria Government Gazette on 30 April 1941 page 1677; and
- (c) the Amendment of Regulations for the Care, Protection, and Management of the ‘Kardinia Oval’, Geelong made on 14 May 1958 and published in the Victoria Government Gazette on 21 May 1958 page 1364; and
- (d) the Regulations for the Care, Protection, and Management of the ‘Kardinia Oval Reserve’, Geelong made on 17 April 1972 and published in the Victoria Government Gazette on 26 April 1972 page 1065; and
- (e) the Amendment to the Regulations for the Care, Protection, and Management of the ‘Kardinia Oval’, Geelong made on 28 June 1973 and published in the Victoria Government Gazette on 4 July 1973 page 2306.

2. Authorising provision

These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

3. Commencement

These Regulations come into operation on the date they are published in the Victoria Government Gazette.

4. Revocation

The following Regulations are revoked –

- (a) the Regulations for the Care, Protection, and Management of Kardinia Park and the Collection and Receipt of Tolls, Entrance Fees, or Charges as made on 26 September 1930 and published in the Government Gazette on 1 October 1930, page 2602; and

- (c) the Amendment of Regulations for the Care, Protection, and Management of the ‘Kardinia Oval’, Geelong made on 14 May 1958 and published in the Victoria Government Gazette on 21 May 1958 page 1364; and
- (d) the Regulations for the Care, Protection, and Management of the ‘Kardinia Oval Reserve’, Geelong made on 17 April 1972 and published in the Victoria Government Gazette on 26 April 1972 page 1065; and
