(2) If a provision of this Act does not come into operation before 31 December 2010, it comes into operation on that day.
- 27/2010 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
(2) If a provision of this Act does not come into operation before 1 January 2011, it comes into operation on that day.
- 28/2010 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
(2) If a provision of this Act does not come into operation before 1 January 2011, it comes into operation on that day.
- 29/2010 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
(2) If a provision of this Act does not come into operation before 1 December 2010, it comes into operation on that day.
- 30/2010 (1) This Part comes into operation on the day on which this Act receives the Royal Assent.
(2) Sections 44(2) and 77 are deemed to have come into operation on 1 January 2010.
(3) Section 84(2) is deemed to have come into operation on 16 December 2009.
(4) Subject to subsection (5), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
(5) If a provision referred to in subsection (4) does not come into operation before 1 January 2012, it comes into operation on that day.

SPECIAL

- 31/2010 (1) Subject to subsections (2) and (3), this Act comes into operation on a day or days to be proclaimed.
- (2) If section 5 does not come into operation before 1 June 2011, it comes into operation on that day.
- (3) If a provision of this Act other than section 5 does not come into operation before 30 June 2010, it comes into operation on that day.
- 32/2010 (1) This Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 January 2011, it comes into operation on that day.
