Wildlife Act 1975

DETERMINATION OF PORT PHILLIP BAY WHALE (DOLPHIN) SWIM TOUR LIMITED PERMIT AREA

The Secretary to the Department of Sustainability and Environment, in accordance with section 83F of the **Wildlife Act 1975**, determines that:

- (i) the area described in Schedule 1 is the Port Phillip Bay Whale (Dolphin) Swim Tour Limited Permit Area (the Permit Area); and
- (ii) the maximum number of whale swim tour permits to be granted for the Permit Area is four (4); and
- (iii) 'dolphin' for the purposes of the determination means any wildlife that is a member of the family Delphinidae of the sub-order Odontoceti of the Order Cetacea, excluding members of the sub-family Globicephalinae (small toothed whales).

By authority, the seal of the Secretary to the Department of Sustainability and Environment was affixed to this determination on 28 July 2010

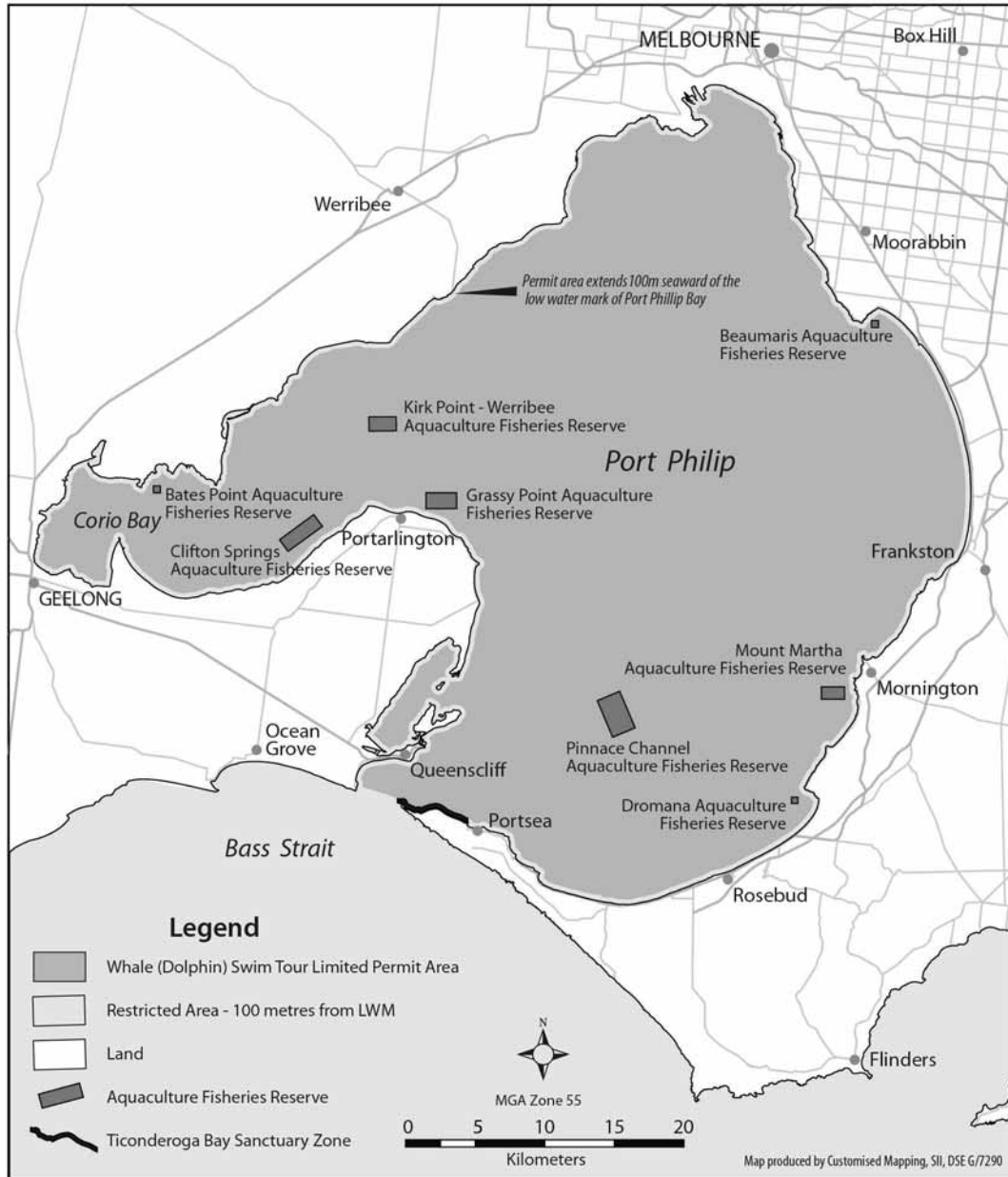
SCHEDULE 1

All the waters of Port Phillip Bay that are more than 100 metres seaward of the low water mark of Port Phillip Bay, except for the area described as the Ticonderoga Bay Sanctuary Zone in the Wildlife (Marine Mammal) Regulations 2009, and the waters of the following areas that are declared by Order in Council as fisheries reserves for aquaculture purposes under section 88 of the **Fisheries Act 1995**, and published in the Government Gazette G10 on 6 March 2003 at pages 399–407:

- Grassy Point Aquaculture Fisheries Reserve
- Clifton Springs Aquaculture Fisheries Reserve
- Kirk Point–Werribee Aquaculture Fisheries Reserve
- Bates Point Aquaculture Fisheries Reserve
- Beaumaris Aquaculture Fisheries Reserve
- Mount Martha Aquaculture Fisheries Reserve
- Dromana Aquaculture Fisheries Reserve
- Pinnacle Channel Aquaculture Fisheries Reserve
