### ADMINISTRATIVE ARRANGEMENTS ORDER (NO. 204) 2010

The Governor in Council makes the following Order:

#### 1. Title

This Order is called the Administrative Arrangements Order (No. 204) 2010.

#### 2. Authorising provisions

This Order is made under sections 3 and 5 of the **Administrative Arrangements Act 1983**.

#### 3. Operation and effect of Order

This Order takes effect on the day it is made.

#### 4. Definitions

In this Order –

‘**Body**’ means Minister, Department or officer;

‘**instrument**’ includes contract and agreement;

‘**Old Body**’ means a Body specified in Column 1 of an item in Table 1 or Table 2 in the Schedule;

‘**New Body**’ means a Body specified in Column 3 of an item in Table 1 or Table 2 in the Schedule;

‘**Schedule**’ means Schedule to this Order;

‘**transaction**’ includes –

(a) agreement, bond, contract, deed or other consensual arrangement; and

(b) action, appeal, arbitration, prosecution or other legal proceeding; and

(c) assignment, charge, lease, mortgage, transfer or other dealing with property; and

(d) loan, guarantee, indemnity or other dealing with money; and

(e) approval, consent, delegation, direction, licence, order, permit, requirement or other authority; and

(f) notice; and

(g) any other act, entitlement or liability at law.

#### 5. Construction of references

In respect of each item in Table 1 in the Schedule, a reference to the Old Body specified in Column 1 of that Table for the item, in an instrument specified in Column 2 of that Table for the item, is deemed to be a reference to the New Body specified in Column 3 of that Table in that item.

**6. Transfers**

In respect of the item in Table 2 in the Schedule, property specified in Column 2 of that Table is transferred from the Old Body specified in Column 1 of that Table to the New Body specified in Column 3 of that Table.

**7. Saving of existing transactions**

If a transaction happened in relation to an Old Body before this Order takes effect –

- (a) this Order does not affect the validity or continuity of the transaction; and
- (b) the transaction shall continue and may be completed in relation to the New Body in the same way as it would have been continued and may have been completed in relation to the Old Body if this Order had not been made; and
- (c) the transaction may be given effect to, or enforced or completed, by the New Body in the same way as it would have been given effect to, or enforced or completed, by the Old Body as if this Order had not been made.

**8. Keeping financial accounts and reports**

The Secretary, Department of Innovation, Industry and Regional Development and the Secretary, Department of Human Services must ensure that financial accounts are kept and reports are provided for the purposes of the **Financial Management Act 1994** until 30 September 2010 in respect of functions under the instruments specified in Schedule 1 that are transferred to CenITex or the Department of Treasury and Finance as if the functions had not been transferred.

**9. Providing financial accounts and reports**

CenITex and the Department of Treasury and Finance must, if requested by the Secretary, Department of Innovation, Industry and Regional Development and the Secretary, Department of Human Services, provide the Secretary, Department of Innovation, Industry and Regional Development and the Secretary, Department of Human Services with any financial accounts and records or other information required to enable the Secretary, Department of Innovation, Industry and Regional Development and the Secretary, Department of Human Services to comply with clause 8.
