Fair Trading Act 1999

PERMANENT BAN ORDER PROHIBITING THE SUPPLY OF DANGEROUS GOODS

I, Tony Robinson, Minister for Consumer Affairs, pursuant to the powers conferred on me by Part 3 Division 1 of the **Fair Trading Act 1999**, hereby make an order prohibiting the supply in Victoria of the following goods:

Flotation toys and aquatic toys which are:

- (a) designed or clearly intended for use in play by children under 14 years of age; and
- (b) intended to bear the mass of a child in water, whether inflatable or not; whether or not worn or attached to the body, including but not limited to
- (c) inflatable novelty shapes;
- (d) inflatable toy boats, which by virtue of their size and design are intended for use in shallow water;
- (e) unattached complete or partial rings

which do not comply with the Consumer Product Safety Standard for Flotation Toys and Aquatic Toys, Consumer Protection Notice No. 2 of 2009 of the Commonwealth, as amended from time to time.

I make this order on the recommendation of Claire Noone, Director of Consumer Affairs Victoria and noting the requirements imposed by the Commonwealth Government on flotation toys and aquatic toys, thereby satisfying the requirements of sections 40(1) and 40(2)(a) of the **Fair Trading Act 1999**.
