## Fair Trading Act 1999

### PERMANENT BAN ORDER PROHIBITING THE SUPPLY OF DANGEROUS GOODS

I, Tony Robinson, Minister for Consumer Affairs, pursuant to the powers conferred on me by Part 3 Division 1 of the **Fair Trading Act 1999**, hereby make an order prohibiting the supply in Victoria of the following goods:

Swimming Aids and Flotation Aids designed for children under 14 years of age worn on or attached to the body or in which the user sits for the purpose of either enabling them to gain confidence through water familiarisation, or to assist them in acquiring unaided buoyancy through swimming tuition;

Including, but not limited to:

- (a) arm bands;
- (b) attached rings;
- (c) swimming aid vests

which do not comply with the Consumer Product Safety Standard for Swimming Aids and Flotation Aids for Water Familiarisation and Swimming Tuition, Consumer Protection Notice No. 3 of 2009 of the Commonwealth, as amended from time to time.

I make this order on the recommendation of Claire Noone, Director of Consumer Affairs Victoria and noting the requirements imposed by the Commonwealth Government on Swimming Aids and Flotation Aids for Water Familiarisation and Swimming Tuition, thereby satisfying the requirements of sections 40(1) and 40(2)(a) of the **Fair Trading Act 1999**.
