## Fair Trading Act 1999

### PERMANENT BAN ORDER PROHIBITING THE SUPPLY OF DANGEROUS GOODS

I, Tony Robinson, Minister for Consumer Affairs, pursuant to the powers conferred on me by Part 3 Division 1 of the **Fair Trading Act 1999**, hereby make an order prohibiting the supply in Victoria of the following goods:

- (a) Spectacles comprising tinted lenses of nominal zero refractive power mounted in a spectacle frame;
- (b) Individual tinted lenses of nominal refractive power intended for use in sunglasses;
- (c) Rimless sunshields and one piece visors;
- (d) Clip-on and slip-on type sunglasses;
- (e) Children's sunglasses;

which do not comply with the Consumer Product Safety Standard: Sunglasses and Fashion Spectacles, Consumer Protection Notice No. 13 of 2003 of the Commonwealth, as amended from time to time.

I make this order on the recommendation of Claire Noone, Director of Consumer Affairs Victoria and noting the requirements imposed by the Commonwealth Government on Sunglasses and Fashion Spectacles, thereby satisfying the requirements of sections 40(1) and 40(2)(a) of the **Fair Trading Act 1999**.
