## Fair Trading Act 1999

### PERMANENT BAN ORDER PROHIBITING THE SUPPLY OF DANGEROUS GOODS

I, Tony Robinson, Minister for Consumer Affairs, pursuant to the powers conferred on me by Part 3 Division 1 of the **Fair Trading Act 1999**, hereby make an order prohibiting the supply in Victoria of the following goods:

Bean Bags, bean bag covers and packages containing bean bag filling which do not comply with Regulation 11 of the Trade Practices (Consumer Product Safety Standards) Regulations 1979 (Statutory Rules 1979 No. 134) of the Commonwealth, as amended from time to time.

I make this order on the recommendation of Claire Noone, Director of Consumer Affairs Victoria, and note the requirements imposed by the Commonwealth Government on bean bags, bean bag covers and packages containing bean bag filling, thereby satisfying the requirements of sections 40(1) and 40(2)(a) of the **Fair Trading Act 1999**.
