**VICTORIA PLANNING PROVISIONS**  
Notice of Approval of Amendment  
Amendment VC69

The Minister for Planning has approved Amendment VC69 to the Victoria Planning Provisions (VPP) and all planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by:

- making changes relating to waste management to Clauses 12.07 and 18.10 of the SPPF;
- introducing a particular provision for resource recovery (Clause 52.45);
- changing Clause 52.10 to introduce a new purpose group of 'Recycling and Resource Recovery' into the table;
- revising the land use terms for 'Materials recycling' and 'Refuse transfer station' throughout the VPP;
- prohibiting a Transfer station and Materials recycling in the Mixed Use Zone; and
- introducing a permit requirement for a Transfer station in the Township Zone, the Industrial 1 Zone, the Business 3 and 4 Zones and the Farming Zone.
