Water Act 1989 (Vic.)

PUBLIC NOTICE

Pursuant to section 287ZE of the **Water Act 1989 (Vic.)**, Western Water gives notice that it proposes to amend Water Restriction By-Law 08/01 ('the By-Law'). The purpose of the proposed amendment is to replace 'Stage 2' water restrictions with a modified Stage 2 in order to reflect the learning of customer behaviours and attitudes experienced in recent years.

Currently, as set out in Schedule 2, Part B of the By-Law:

- No provision in the case of residential properties where at least one occupant is aged 70 or older.
- A commercial car wash may only operate if it uses less than 100 litres of water per vehicle.

The proposed amendments to the By-Law would increase the number of days on which residential and commercial gardens, public gardens and sportsgrounds may be watered by allowing:

- Properties with at least one occupant over the age of 70 years may water on specified watering days between 8.00 am and 10.00 am instead of the standard morning watering time of between 6.00 am and 8.00 am. No exemption is required.
- A commercial car wash may only operate if it uses less than 70 litres of water or less per vehicle.

A copy of the By-Law containing the proposed amendments may be inspected, free of charge, at the following locations:

- the offices of Western Water during ordinary business hours;
- the Western Water website.

Western Water invites submissions on the proposed amendments to the By-Law. Any person who is affected by the proposed amendments to the By-Law may make a submission on the proposed amendments to Western Water. Submissions must be made in writing (whether by means of electronic communication or otherwise) and must be received by the Authority within one calendar month of the publication of this notice.
