## Water Act 1989

### ANGLESEA MANAGED AQUIFER RECHARGE EXEMPTION ORDER 2010

I, Tim Holding MP, Minister for Water, as Minister administering the **Water Act 1989**, make the following Order:

#### Citation

1. This Order is called the Anglesea Managed Aquifer Recharge Exemption Order 2010.

#### Authorising provision

2. This Order is made under section 308 of the **Water Act 1989** (the Act).

#### Purpose

3. The purpose of this Order is to allow Gippsland and Southern Rural Water Corporation (also known as Southern Rural Water) to consider an application under section 51 of the Act by Barwon Region Water Corporation to take and use a maximum of 20 megalitres of groundwater over a period of seven consecutive days between 1 September and 30 November 2010 for the purpose of conducting a pumping test to ascertain the viability of an aquifer in the Jan Juc groundwater management area for use as a managed aquifer recharge site.

#### Commencement

4. This Order commences on the date it is published in the Government Gazette.

#### Exemption

5. Gippsland and Southern Rural Water Corporation is exempt from the requirement contained in section 55(2B)(a) of the Act in relation to an application under section 51 of the Act made by Barwon Region Water Corporation dated 11 May 2010.
