Accident Towing Services Act 2007

DETERMINATION OF FEES

1. Purpose

The purpose of this notice to determine fees for applications under the **Accident Towing Services Act 2007**.

2. Authorising Provision

This notice is made under section 213 of the **Accident Towing Services Act 2007**. Section 213 provides that VicRoads may, by notice published in the Government Gazette, determine fees for applications under that Act.

3. Commencement

This notice comes into operation from the date it is published in Government Gazette.

4. Determination

I, Gary Liddle, Chief Executive of VicRoads, determine the fees set out in column 2 of the table below in respect of the corresponding applications in column 1 of the table.

Replacement certificate of accreditation operator and depot manager	\$21.50
Tow truck driver accreditation	\$64.00
Replacement certificate of accreditation (tow truck driver)	\$21.50
Tow truck trainee permit	\$21.50
