## Planning and Environment Act 1987

### DECLARATION OF GROWTH AREAS

I, Justin Madden, Minister for Planning, make the following Order under section 46AO of the **Planning and Environment Act 1987**.

The area of land within the urban growth boundary within the municipal district of the Mitchell Shire Council, as shown in the planning scheme for the Mitchell Shire Council on the date of this Order, is declared to be the Mitchell Growth Area.

The area of land within the urban growth boundary within the municipal district of the Hume City Council as shown in the planning scheme for the Hume City Council on the date of this Order with the exception of land within the urban growth boundary of the township of Bulla is added to the Hume Growth Area declared by Order published in the Government Gazette and dated 15 January 2007.

The area of land within the urban growth boundary within the municipal district of the Casey City Council, as shown in the planning scheme for the Casey City Council on the date of this Order is added to the Casey–Cardinia Growth Area declared by Order published in the Government Gazette and dated 15 January 2007.

The area of land within the urban growth boundary within the municipal district of the Melton Shire Council, with the exception of land within the urban growth boundary of the township of Toolern Vale as shown in the planning scheme for the Melton Shire Council on the date of this Order, is added to the Melton–Caroline Springs Growth Area declared by Order published in the Government Gazette and dated 15 January 2007.

The area of land within the urban growth boundary within the municipal district of the Whittlesea City Council, as shown in the planning scheme for the Whittlesea City Council on the date of this Order, is added to the Whittlesea Growth Area declared by Order published in the Government Gazette and dated 15 January 2007.

The area of land within the urban growth boundary within the municipal district of the Wyndham City Council, as shown in the planning scheme for the Wyndham City Council on the date of this Order, is added to the Wyndham Growth Area declared by Order published in the Government Gazette and dated 15 January 2007.

This Order comes into operation on the date it is published in the Government Gazette.
