NOTICE OF PREPARATION OF A REGULATORY IMPACT STATEMENT

Port Services (Port of Melbourne Safety and Other Matters) Regulations 2010

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared for the proposed Port Services (Port of Melbourne Safety and Other Matters) Regulations 2010.

The objectives of the proposed regulations are to provide for the safe and effective management within the Port of Melbourne of:

- hazardous port activities;
- bunkering and the transfer of other liquid substances to and from vessels and wharves in the port; and
- abandoned things.

The RIS assesses the benefits and costs of the proposed regulations, concluding that the benefits outweigh the expected costs.
