The participants will offer support to each other and practical assistance where that is appropriate.
- The role of the mentor is to introduce the program, undertake ceremonial duties and facilitate discussions between participants. The ceremonial duties can only be undertaken by an Indigenous person.
- Given the nature of the applicant organisation and the programs to be offered, it is appropriate that the mentor for each of the men's and women's groups is of the same sex and is an Indigenous person.

PERMISSIBLE CONSUMPTIVE VOLUME SURFACE WATER ORDER 2010

Citation

1. This Order is called the Permissible Consumptive Volume Surface Water Order 2010.

Authorising Provision

This Order is made under the powers conferred by section 22A of the Water Act 1989 (the Act) and all other available powers.

Commencement

3. This Order takes effect on and from the date it is published in the Victorian Government Gazette.

Revocation of Earlier Order

 On and from the date on which this Order takes effect the Permissible Consumptive Volume Surface Water Order 2006 is revoked.

Definitions

5. In this Order –

'Act' means the Water Act 1989;

'conservation licence' means a licence under section 130 or 138 of the Land Act 1958 over a Crown frontage which does not permit grazing for more than one month in any year;

'stormwater works' means -

- a channel, drain or pipe or associated works, including box culverts, that collects or conveys stormwater runoff from an urban area or development and that is owned or operated by a water corporation for the purpose of carrying out its functions under the Act: or
- ii. a retarding basin or wetland that holds or treats stormwater runoff from an urban area or development and that is constructed or operated by a water corporation for the purpose of carrying out its functions under the Act; or
- iii. in the case of Melbourne Water Corporation, works listed in Melbourne Water Corporation's asset register and used for the purpose of carrying out its regional drainage functions under Part 10 of the Act;

'water season' means any period of 12 calendar months beginning on 1 July in any year and ending on 30 June in the following year.

Areas to Which the Order Applies

- 6. The areas to which this Order applies are those areas in Victoria shown in Column A and B of the Table below, as defined by the digital data set of River Basins set by the former Australian Water Resource Council, held by Geoscience Australia (National Mapping Agency) dated 30 June 1997, and as reproduced in the Victorian Water Accounts 2007/08 (Victorian Government Department of Sustainability and Environment, Melbourne); and
- 7. Each area is or shall be known by the name listed in Column A of the Table.

Permissible Consumptive Volumes

EXEMPTION FOR VICTORIAN ANIMAL AID TRUST FROM SPECIFIC OPERATION OF SECTION 63A

Order in Council

The Governor in Council under section 5 of the **Domestic Animals Act 1994** exempts the proprietors of the 'Victorian Animal Aid Trust' from the operation of section 63A of the Act in relation to compliance with section 2.3.6(d) of the 'Code of Practice for the Management of Dogs and Cats in Shelters and Pounds,' of which the making of was published in the Government Gazette G45 on 12 November 1998 (page 2750), requiring that dogs being exercised must be confined within the shelter premises, subject to the following conditions –

- (a) the exemption only applies to dogs currently identified in the Animal Rehabilitation Training program that have undergone and been assessed for temperament to the satisfaction of the proprietor of the 'Victorian Animal Aid Trust';
- (b) that these dogs may only be exercised at the Lilydale-Warburton Rail Trail and within the car park area of PETstock, Lilydale at 445-449 Maroondah Highway, Lilydale, with permission of the controlling agency for these areas;
- (c) that these dogs may only be exercised outside the premises of the 'Victorian Animal Aid Trust' on a chain, cord or leash attached to an experienced dog handler approved by the proprietor of the 'Victorian Animal Aid Trust' and that these dogs must remain under the control of that handler while in the areas mentioned in paragraph (b);
- (d) no transactions for adoption may occur in the areas mentioned in paragraph (b).
