### CANCELLATION OF PETROLEUM EXPLORATION PERMIT VIC/P65

I, Doug Sceney, the Delegate of the Designated Authority for the offshore area of Victoria, and on behalf of the Commonwealth–Victoria Offshore Petroleum Joint Authority, pursuant to the provisions of section 275 of the **Offshore Petroleum and Greenhouse Gas Storage Act 2006**, hereby cancel Petroleum Exploration Permit VIC/P65, in respect of the blocks described hereunder, of which Strategic Energy Resources Ltd is the registered holder, on the following grounds:

#### **Non-compliance with Condition 1 (Year 2 work commitments) of Petroleum Exploration Permit VIC/P65**

This cancellation takes effect on the day on which a notice of the cancellation is published in the Victoria Government Gazette.
