I, Diane Julie Bates, the Director Maritime Safety (as delegate of the Director, Transport Safety) on the recommendation of Vin Wright, Manager of Operations, Bays and Maritime Division, Parks Victoria (the Waterway Manager for the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 9.00 am Monday 27 September 2010 till 5.00 pm Friday 24 December 2010 bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie) excluding those vessels involved with the Mornington Pier rebuild and those owned and operated by Parks Victoria is prohibited within the exclusion zone as detailed in Table 1.

Table 1: Mornington Harbour Exclusion Zone

The waters bounded by:	
(i)	A line extending from a point on shore 38° 12.740· S, 145° 2.049· E; to a point on the shore 38° 12.730· S, 145° 2.024· E
(ii)	A line extending from a point on the shore 38° 12.730· S, 145° 2.024· E; to a point on the water 38° 12.724· S, 145° 2.014· E
(iii)	A line extending from a point on the water 38° 12.724· S 145° 2.014· E to a point on the water 38° 12.675· S 145° 2.108· E
(iv)	A line extending from a point on the water 38° 12.675· S 145° 2.108· E to a point on the water 38° 12.696· S 145° 2.131· E
(v)	A line extending from a point on the water 38° 12.696· S 145° 2.131· E to a point on the water 38° 12.757· S 145° 2.008· E
(vi)	A line extending from a point on the water 38° 12.757· S 145° 2.008· E to a point on the water 38° 12.753· S 145° 2.004· E
(vii)	A line extending from a point on the water 38° 12.753· S 145° 2.004· E to a point on the shore 38° 12.736· S 145° 2.044· E
(viii)	A line extending from a point on the shore 38° 12.736· S 145° 2.044· E to a point on the shore 38° 12.740· S, 145° 2.049· E

2. at the completion of the works or as announced by Parks Victoria the waters will revert to the provisions of Schedule 1 contained in Notice No.1 under section 15(2) of the **Marine Act 1988**.
