Water Act 1989

APSLEY AND KANIVA WATER SUPPLY PROTECTION AREAS EXEMPTION ORDER 2010

I, Tim Holding MP, Minister for Water, as Minister administering the **Water Act 1989**, make the following Order:

Citation

1. This Order is called the Apsley and Kaniva Water Supply Protection Areas Exemption Order 2010.

Authorising provision

2. This Order is made under section 308 of the **Water Act 1989** (the Act).

Purpose

3. The purpose of this Order is to allow consideration of an application made by the Grampians Wimmera Mallee Water Corporation to take and use groundwater for the purpose of urban water supply for the towns of Apsley in the Apsley Water Supply Protection Area and Kaniva and Lillimur in the Kaniva Water Supply Protection Area.

Duration

4. This Order commences on the date that it is published in the Government Gazette and remains in force until the applications made by Grampians Wimmera Mallee Water Corporation dated 3 August 2010 for licences to take and use groundwater for urban water supply in the Apsley Water Supply Protection Area and the Kaniva Water Supply Protection Area have been granted or refused.

Exemption

5. The Minister administering the Act is exempt from the requirement contained in section 54(2)(c) of the Act to defer an application under section 51 of the Act in relation to the applications by Grampians Wimmera Mallee Water Corporation dated 3 August 2010 for licences to take and use groundwater for urban water supply in the Apsley Water Supply Protection Area and the Kaniva Water Supply Protection Area.
