### PROCLAMATION

- 63/2010     **Consumer Affairs Legislation Amendment (Reform) Act 2010**  
64/2010     **Justice Legislation Further Amendment Act 2010**  
65/2010     **Marine Safety Act 2010**  
66/2010     **Occupational Licensing National Law Act 2010**  
67/2010     **Residential Tenancies Amendment Act 2010**

- 63/2010     (1) This Part and Part 4 come into operation on the day after the day on which this Act receives the Royal Assent.  
(2) Section 81 and the Schedule come into operation on the day on which section 42 of the **Consumer Affairs Legislation Amendment Act 2010** comes into operation.  
(3) Subject to subsection (4), the remaining provisions of this Act come into operation on a day or days to be proclaimed.  
(4) If a provision referred to in subsection (3) does not come into operation before 1 September 2011, it comes into operation on that day.
- 64/2010     (1) Part 1 and Part 9 come into operation on the day after the day on which this Act receives the Royal Assent.  
(2) Part 2 comes into operation on 1 November 2010.  
(3) Part 6 comes into operation on 1 January 2011.  
(4) Section 21 is taken to have come into operation on 12 December 2005.  
(5) Section 22 comes into operation on 1 July 2011.  
(6) Subject to subsection (7), Part 7 comes into operation on a day to be proclaimed.  
(7) If Part 7 does not come into operation before 1 July 2011 it comes into operation on that day.  
(8) Subject to subsections (9), (10) and (11), the remaining provisions of this Act come into operation on a day or days to be proclaimed.  
(9) If a provision of this Act referred to in subsection (8) (except Parts 8 and 11) does not come into operation before 1 October 2011, it comes into operation on that day.  
(10) If a provision of Part 8 does not come into operation before 1 September 2012, it comes into operation on that day.  
(11) If a provision of Part 11 does not come into operation before 1 January 2011, it comes into operation on that day.

- 65/2010 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
(2) If a provision of this Act does not come into operation before 1 July 2012, it comes into operation on that day.
- 66/2010 (1) This Act comes into operation on a day or days to be proclaimed.  
(2) Different provisions of the National Law set out in the Schedule may be proclaimed to come into operation on different days.
- 67/2010 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
(2) If this Act, except Part 7, does not come into operation before 31 March 2012, it comes into operation on that day.
