SECTION 15 NOTICE

I, Diane Julie Bates, the Director Marine Safety (as delegate of the Director, Transport Safety), on the recommendation of Inspector Stephen Guilmartin, Officer in Charge, Water Police Squad – Search and Rescue Squad (member of the Victoria Police), hereby give notice under section 15(2) of the **Marine Act 1988** that:

1. from 5.00 pm Thursday 9 September 2010 till 5.00 pm Thursday 16 September 2010 bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie) excluding those vessels involved in search and rescue operations, is prohibited on the following waters:
 - a. All the waters of the Goulburn River from the Goulburn River Weir to the junction of the Murray River;
 - b. All the waters of the Gowangardie Weir and Broken River from the Gowangardie Weir to the junction of the Goulburn River.

1. from 12.01 pm Wednesday 8 September 2010 till 5.00 pm Thursday 16 September 2010 bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie) excluding those vessels involved in search and rescue operations, is prohibited on the waters of the Ovens River from the Murray Valley Highway to Wangaratta Road, Wangaratta.
