## Crown Land (Reserves) Act 1978

### ORDER GIVING APPROVAL TO THE GRANT OF A LICENCE UNDER SECTIONS 17B AND 17DA

Under sections 17B and 17DA of the **Crown Land (Reserves) Act 1978**, I, Ryan Smith MP, Minister for Environment and Climate Change, being satisfied that there are special reasons which make the granting of a licence reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a licence to Rip Curl (International) Pty Ltd and Surfing Victoria Incorporated by the Surf Coast Shire Council as the Committee of Management, for the purpose of conducting the Rip Curl Pro Surfing Competition over the area of Crown land being the Bells Beach Surfing and Recreation Reserve described in the Schedule below and, in accordance with section 17B(3)(a) of the **Crown Land (Reserves) Act 1978**, state that –

- (a) there are special reasons which make granting the licence reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.

The land indicated by yellow outline on plan marked 'JJ/8.2.2008' attached to Department of Sustainability and Environment file No. 0700242 being portion of Allotment 20A, Parish of Jan Juc being Crown land permanently reserved for the Protection of the Coastline by Order in Council of 11 August 1981 and by notice published in the Government Gazette on 19 August 1981, page 2766.
