**Marine Act 1988**

## SECTION 15 NOTICE

I, Lisa Faldon, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Manager of Operations, Bays and Maritime Division, Parks Victoria (Waterway Manager for the Designated Port of Western Port), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 3.00 pm to 3.30 pm Saturday 5 February 2011, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding those vessels involved with the Cowes Classic Ocean Swim event and those owned and operated by Parks Victoria, is prohibited on the following waters of the Designated Port of Western Port:
  - (a) within 300 metres to seaward from the edge of the water between two lines extending to seaward at right angles to the shore:
    - (i) one line extending from Mussel Rock approximately 300 metres west of Cowes Jetty; and
    - (ii) the other line extending from the beacon with a red triangular topmark on Erehwon Point, Phillip Island.
2. From 9.00 am to 9.45 am Sunday 6 February 2011, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding those vessels involved with the Phillip Island Penguin Swim Classic event and those owned and operated by Parks Victoria, is prohibited on the following waters of the Designated Port of Western Port:
  - (a) within 300 metres to seaward from the edge of the water between two lines extending to seaward at right angles to the shore:
    - (i) one line extending seaward from Sanders Road, Cowes; and
    - (ii) the other line extending from and along the eastern side of the Cowes Jetty, Phillip Island.
3. At the completion of the events and/or as determined and announced by Parks Victoria, the waters will revert to the provisions of Schedule 5 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
